## 2. COMPLIANCE REVIEW

The Office of Compliance and Enforcement (OCE) completed a review to determine whether the applicant established that the original tobacco products for EX0001069, EX0001070, EX0001073, and EX0001074 are grandfathered products (i.e., were commercially marketed in the United States as of February 15, 2007). The OCE review dated September 28, 2020, concludes that the evidence submitted by the applicant is adequate to demonstrate original tobacco products are grandfathered products.

The original tobacco products in EX0001067 and EX0001258 were determined to be exempt from the requirements of section 905(j) of the Federal Food, Drug, and Cosmetic Act (FD&C Act) relating to the demonstration of substantial equivalence by FDA. Reports under section 905(j)(1)(A)(ii) (Abbreviated Reports) were submitted, and at least 90 days have elapsed since receipt of the Abbreviated Reports by FDA.

The original tobacco products in EX0001062-EX0001065, EX0001071, and EX0001072 were determined to be substantially equivalent and in compliance with the Federal Food, Drug, and Cosmetic Act (FD&C Act) by FDA.

Therefore, the original tobacco products are eligible for modification under the Exemption Request pathway.<sup>5</sup>

### 3. TOBACCO ADDITIVE MODIFICATION

The applicant claims that the modifications of the original tobacco products compared to the corresponding new tobacco products are the result of:

- deleting an additive (non-FSC cigarette paper) in EX0001069, EX0001070, EX0001073, and EX0001074.
- deleting an additive (FSC cigarette paper) in EX0001071 and EX0001072
- adding an additive (FSC cigarette paper) in EX0001069-EX0001074
- deleting an additive (cork or white tipping paper) in EX0001062-EX0001065, EX0001069, EX0001070, EX0001073, EX0001074, and EX0001258
- adding an additive (alternate cork or white tipping paper) in EX0001062-EX0001065, EX0001069, EX0001070, EX0001073, EX0001074, and EX0001258
- deleting an additive (filter tow) in EX0001067, EX0001069-EX0001071
- adding an additive (alternate filter tow) in EX0001067, EX0001069-EX0001071
- deleting an additive (printed monogram ink) in EX0001062 -EX0001063, EX0001071, and EX0001072
- adding an additive (alternate printed monogram ink) in EX0001062 -EX0001063
- deleting additives (complex purchased flavors: “(b) (4) ” and (b) (4) (b) (4) in EX0001071 and EX0001072
- increasing the quantities of existing additives (b) (4) and (b) (4) in EX0001071 and EX0001072
- increasing the quantity of an existing additive (tipping paper adhesive) in EX0001062-EX0001065
- deletion of box container closure system in EX0001062 and EX0001064
- addition of soft pack container closure system in EX0001062 and EX0001064

### 4. SCIENTIFIC REVIEW

The review finds these modified ingredients (see Section 3) are additives because their intended use may reasonably be expected to result, directly or indirectly, in their becoming a component or otherwise affecting the characteristics of the tobacco products. The review concludes that the modifications are minor modifications of a tobacco product in accordance with section 905(j)(3)(A)(i) of the FD&C Act.

## 5. ENVIRONMENTAL DECISION

A finding of no significant impact (FONSI) was signed by Luis Valerio, Ph.D. on October 7, 2020. The FONSI was supported by an environmental assessment prepared by FDA on October 1, 2020.

## 6. CONCLUSION AND RECOMMENDATION

I concur with the conclusion of the scientific review that these modifications (see Section 3) are minor modifications of a tobacco product in accordance with section 905(j)(3)(A)(i) of the FD&C Act. I concur that the modified ingredients are “additives” as defined in section 900(1) of the FD&C Act. In addition, it is my conclusion that, consistent with section 905(j)(3)(A)(ii) of the FD&C Act, an SE Report is not necessary to ensure that permitting the new tobacco products to be marketed would be appropriate for the protection of the public health.

The changes to the tipping paper from cork to cork, white to cork, or white to white in EX0001062-EX0001065, EX0001069-EX0001070, EX0001073, EX0001074, EX0001258 and increase in the quantity of tipping paper adhesive in EX0001062-EX0001065 are minor modifications. These changes are not expected to have any significant effects because the increase in tipping paper adhesive is relatively small and the tipping paper is not combusted, volatilized, or otherwise released during normal cigarette consumption. Deletion of red monogram ink and addition of blue monogram ink has overall fewer number of chemicals in the new products compared to the corresponding original tobacco products in EX0001062 and EX0001063. Also, added or increased ingredients in the new tobacco products compared to their corresponding original tobacco products are very low and minor for any appreciable risk from exposures to these ingredients at the levels submitted by the applicant. Similarly, in EX0001071 and EX0001072, the deletion of blue monogram ink from the barrel of the original tobacco products also reduces the chemicals for combustion and would also not increase potential health risks. Deletion of filter tow and addition of an alternate filter tow in EX0001067, EX0001069-EX0001071 is not expected to materially affect any other characteristic (materials, ingredients, design, composition, heating source, or other features) of the products. The filter tow can influence the ventilation and filter efficiency of a product; however, the ventilation of the new and corresponding original tobacco products remains the same. In EX0001071 and EX0001072, deletion of complex flavors (b) (4) and (b) (4) from the tobacco casing and increasing the quantity of (b) (4) and (b) (4) in the tobacco casing are minor and not expected to significantly alter the smoke chemistry and consumer exposure to chemical constituents. The applicant also proposes deletion of FSC cigarette paper and addition of an alternate FSC cigarette paper for EX0001071 and EX0001072 as well as deletion of non-FSC cigarette paper and addition of FSC cigarette paper in EX0001069, EX0001070, EX0001073, and EX0001074.

At this time, based on the information available and CTP’s scientific understanding and experience with non-FSC to FSC cigarette paper modifications that are limited to changes in tobacco additives and do not result in other changes to the product (e.g., no changes to blend, filter, design parameters such as ventilation, etc.), the benefit of using FSC paper in cigarettes to reduce household fires is anticipated to outweigh any potential increased health risks from the small increases in HPHC exposures that may occur from the use of FSC paper. Based on the information submitted by the applicant, there is an additional modification for EX0001062 and EX0001064 of a change in container closure system (i.e., from box in the original product to soft pack in the new

product). I, as TPL, find that the container closure systems in the original and new product meet the definition of 'additive' because they are substances used in the packaging of the tobacco products. In addition, I find that this modification is minor because this modification does not affect the characteristics of the consumable portion of the tobacco products. Lastly, I find that an exemption for these modifications is otherwise appropriate as required by section 905(j)(3)(A)(iii) of the FD&C Act. Therefore, the new tobacco products should be found exempt from the requirements of substantial equivalence under section 910(a)(3)(A) of the FD&C Act.

The original tobacco products are eligible for modification through the Exemption Request pathway because they can be legally marketed in the United States. The original tobacco products for EX0001069, EX0001070, EX0001073, and EX0001074 are grandfathered (i.e., were commercially marketed in the United States as of February 15, 2007); the original tobacco products for EX0001067 and EX0001258 were previously found Exempt by FDA, and reports under section 905(j)(1)(A)(ii) (Abbreviated Reports) were submitted, and 90 days have elapsed since FDA receipt of the Abbreviated Reports; and the original products for EX0001062-EX0001065, EX0001071, and EX0001072 were previously found SE and in compliance with the FD&C Act by FDA.

FDA has examined the environmental effects of finding the new tobacco products exempt and made a finding of no significant impact.

Exempt orders should be issued for the new tobacco products in EX0001062-EX0001065, EX0001067, EX0001069-EX0001074, and EX0001258, as identified on the cover page of this review.
