


Manufactured Food Regulatory Program Standards (MFRPS)

THE PURPOSE OF THE MFRPS

- Enhance the nation’s food safety, as directed by the Food Safety Modernization Act (FSMA)
- Provide the tools and resources to enable state food regulatory programs to build strong infrastructures and systems that complement national uniformity and promote an integrated food safety system
- Promote quality regulatory programs through continuous self-improvement
- Improve communication among regulatory and public health partners

FDA SUPPORT FOR STATE PROGRAMS

- Offers dedicated FDA staff to work with your program staff
- Provides information-sharing forums through the Manufactured Food Regulatory Program Alliance (MFRPA) portal and FoodSHIELD website
- Furnishes opportunities to regulatory programs enrolled in the MFRPS to apply for funding, when available, to assist in their implementation efforts

LEVERAGING RESOURCES

- Assess gaps and set priorities for program improvements through MFRPS' self-assessment approach
- Use MFRPS tools to complete a resource assessment to help justify existing resources or to request increased resources
- Take advantage of opportunities for states to network, learn, and work with other state regulatory programs by facilitating information-sharing and improved communications
