

I. Overview

This is a basic example of a salad kit prepared with cherry tomatoes, iceberg lettuce, and other foods that are not on the Food Traceability List (FTL), with a focus on the tomato grower, salad kit maker, distributor and retail store (**Diagram 1a**). This example was originally presented as a PowerPoint presentation during three public meetings that were held in late 2020 to discuss the proposed rule. The original presentation during the public meetings included abbreviated data due to time constraints.

As discussed at the public meeting, this is only one example and it does NOT represent the only way data can be kept and shared under the proposed rule. Furthermore, this is a hypothetical example in which the Food Traceability Proposed Rule has been finalized without changes. In reality, the proposed rule has not yet been finalized, and it is possible that the final rule will differ from the proposed rule.

Diagram 1.a: Example of a Salad Kit Supply Chain



The finished product is a salad kit made from cherry tomatoes, iceberg lettuce and non-FTL ingredients. The example focuses on the cherry tomatoes. Full information is therefore not provided about the iceberg lettuce, although some information about the iceberg lettuce is included under the First Receiver, Receiving, and Transformation Key Data Elements (KDEs) at the Produce Processor.

Diagram 1.b: Example of Required Records for Salad Kit Supply Chain




Diagram 1.b provides a quick snapshot of the records that the proposed rule would require -- including Traceability Program Records and records relating to critical tracking events (CTEs) -- for each supply chain participant.

Traceability program records and KDEs for the applicable CTEs were shown as abbreviated spreadsheets during the public meeting but are shown in full in this document. The records shown in this document are represented in a technology agnostic manner but were originally developed using a spreadsheet application.

II. Tomato Farm Traceability Records

II.a Tomato Farm Scenario Overview

- *Tom's Produce* (the "Farmer" in this scenario) is a large produce company that contracts with several companies to grow, harvest, pack and ship fresh produce, including cherry tomatoes.
- *Tom's Produce* retains ownership of the crop from planting until it is shipped to the processor, and has agreed to keep and send records on behalf of the following entities:
 - Tom's Tomato Farm #1 grows the cherry tomatoes; owned by Tom Jr.
 - Harry's Harvesting harvests the cherry tomatoes
 - Pattie's Packers cools and packs the cherry tomatoes
 - Johnson's Storage stores and ships packed cherry tomatoes for Tom's Produce

II.b Farmer's Traceability Program Records, Description of Reference Records

<u>Proposed § 1.1315</u> would require persons subject to the rule to establish and maintain certain traceability program records. These are described in proposed § 1.1315(a)(1), (2), (3), and (4). Table 2.b shows how *Tom's Produce* chooses to maintain the information from proposed § 1.1315(a)(1), which is:

- 1) a description of the reference records in which the company maintains the information required under the rule;
- 2) an explanation of where on the records the required information appears, and
- 3) if applicable, a description of how reference records for different tracing events for a food (e.g., receipt, transformation, shipment) are linked.

The proposed rule includes the following discussion of proposed § 1.1315(a)(1): "We encourage firms to maintain required traceability information in a single electronic system; however, we recognize there are firms that currently do not have product tracing systems that enable them to do this. We therefore propose to require firms to describe the particular types of reference records in which they keep the required tracing information to help expedite the firm's production of records and facilitate FDA's review of those records during a foodborne illness outbreak investigation. In some recent foodborne illness outbreaks, firms' inability to quickly identify and make available to the FDA pertinent information on such matters as production, receipt, and shipment of a possibly contaminated food has significantly delayed completion of our investigation, resulting in greater harm to consumers. Furthermore, even when a firm produces the relevant records, additional delays can occur when it is difficult to find the relevant information on those records." (See 85 FR 59984, 60004-05.)

II.c Farmer's Traceability Program Records, Listing of FTL Foods Shipped

<u>Proposed § 1.1315(a)(2)</u> would require persons subject to subpart S to establish and maintain a list of foods on the Food Traceability List that they ship, including the "traceability product identifier" and "traceability product description" for each food. <u>Proposed § 1.1310</u> would define those two terms as follows:

- "Traceability product identifier means a unique identification code (such as an alphanumeric code) that an entity assigns to designate a specific type of food product."
- "Traceability product description means a description of a food product typically used commercially for purchasing, stocking, or selling, and includes the category code or term, category name, and trade description. For single-ingredient products, the trade description includes the brand name, commodity, variety, packaging size, and packaging style. For multiple-ingredient food products, the trade description includes the brand name, product name, packaging size, and packaging style."

II.d Farmer's Traceability Program Records, Traceability Lot Code Assignment Method

Proposed § 1.1315(a)(3) would require persons subject to subpart S to establish and maintain a description of how they establish and assign traceability lot codes to foods on the Food Traceability List that they originate, transform, or create, if applicable. As explained in the proposed rule, "Because of the significance of lot codes in food tracing, understanding how a firm creates and assigns traceability lot codes would provide [FDA] with information about the relevance of a code to a particular outbreak investigation and insight on how the code can help [FDA] appropriately narrow or broaden the investigation." (See 85 FR 59984, 60006.)

II.e Farmer's Traceability Program Records, Other Information, Location Master Listing

<u>Proposed § 1.1315(a)(4)</u> would require persons subject to subpart S to establish and maintain records containing any other information needed to understand the data provided within any required subpart S records, such as internal or external coding systems, glossaries, and abbreviations. As described in the proposed rule, "[FDA] need[s] this information to be able to adequately understand the terminology, methods, and systems a firm uses in its traceability operations." (See <u>85 FR</u> 59984, 60006.)

In this example, *Tom's Produce* has opted to maintain a location master list that links each location identifier that is used in their recordkeeping to the corresponding location description, as shown in **Table 2.e.**

II.f Farmer's Growing KDEs (kept)

Proposed § 1.1325 would require persons who grow a listed food to establish and maintain records containing and linking the traceability lot code of the food to the growing area coordinates for that lot. The proposed rule explains: "To meet this requirement to record growing area coordinates, farms typically would maintain the GPS coordinates for the entrance of the specific field or ranch where the food was grown." (See 85 FR 59984, 60007.)

In this example, *Tom's Produce* maintains this information in **Table 2.f**.

II.g Farmer's Receiving KDEs (kept)

<u>Proposed § 1.1335</u> would require persons subject to subpart S to establish and maintain records containing KDEs related to the receiving of listed foods.

For this example, Tom's Produce maintains the records for Tom's Tomato Farm, Harry's Harvesting, Pattie's Packers and Johnson's Storage. Therefore, Tom's Produce has agreed to keep the KDEs for the receiving of product at Pattie's Packers Packing Shed (PP-PS) from Tom's Tomato Farm #1 (TTF1) and at Johnson's Storage Warehouse #4 (JS-W4) from Pattie's Packers Packing Shed (PP-PS) – shown in **Table 2.g**.

As in prior examples, **Table 2.g** does not include certain product description and location description information, because *Tom's Produce* chooses to utilize master files to link such information to the relevant traceability product identifiers and location identifiers, respectively.

II.h Farmer's Shipping KDEs (kept and sent)

<u>Proposed § 1.1350(a)</u> would require persons subject to subpart S to establish and maintain records containing specific KDEs related to the shipping of listed foods. In addition, proposed § 1.1350(b)(1) would require that some (but not all) of the KDEs identified in proposed § 1.1350(a) be sent to the immediate subsequent recipient of the food, either in electronic or written form.

As discussed above, *Tom's Produce* captures the Shipping KDEs between Tom's Tomato Farm #1 (TTF1) and Pattie's Packers Packing Shed (PP-PS), and between Pattie's Packers Packing Shed and Johnson's Storage Warehouse #4 (JS-W4). *Tom's Produce* also keeps and sends the Shipping KDEs between Johnson's Storage (JS-W4) and the immediate subsequent recipient (in this example, the firm *Fresh Processor* Plant #16, FP-PL-16).

Tom's Produce maintains this information in **Table 2.h**. Each column title in **Table 2.h** indicates whether the data is kept and sent, or simply kept.

Table 2.h does not include the traceability product description, the lot code generator's location description, the immediate subsequent recipient's location description for the location from which the food was (all of which are KDEs that would be required to be both kept and sent under proposed § 1.1350). This is because *Tom's Produce* chooses to instead provide relevant entries from the Listing of FTL Foods Shipped (**Table 2.c**) and the Location Master List (**Table 2.e**), which link the traceability product identifiers and the various location identifiers used in **Table 2.h** to the relevant traceability product descriptions, respectively.

II.i Farmer's Send-Only KDEs (sent)

As discussed above, proposed § 1.1350(b)(1) would require certain KDEs about shipping to be both maintained by the entity that shipped the product, and also sent to the immediate subsequent recipient of the food. In addition to this provision, proposed § 1.1350(b)(2) would require farms to send additional information to the immediate subsequent recipient.

Tom's Produce maintains these farm-specific shipping KDEs in **Table 2.i.**

Similar to the situation described above regarding **Table 2.i** does not include certain location description information, because *Tom's Produce* chooses to utilize a Location Master List that links location identifiers to location descriptions.

As explained in the proposed rule: "We are proposing the additional information disclosure requirements for shippers who are farms because we propose to require that the first receiver of a food on the Food Traceability List (i.e., the first person other than a farm who purchases and takes physical possession of the food) maintain this information, and we understand that not all farms routinely provide this information to firms that buy food from the farms.

Therefore, we believe it is appropriate to require farms to provide information on the origination (if not by the farm), harvesting, cooling, and packing of the food (if applicable) when they ship the food.

"In situations where food is sold from one farm to a second farm before being sold to a first receiver, this system would allow for all of the necessary information to reach the first receiver, even if some of the activities (e.g., origination and harvesting) took place on the first farm, while others (e.g., cooling and packing) took place on the second farm. In that situation, the first farm would be obligated under proposed § 1.1350(b)(1) to send information about their location to the second farm, and they would be obligated under proposed § 1.1350(b)(3)(iii) to send the second farm information about the date and time of harvesting. This would allow the second farm to fulfill its obligation under proposed § 1.1350(b)(2)(ii) and (iii) to send the first receiver information about the originator of the food and the date and time of harvesting. Moreover, the statement that the sender is a farm would allow the first receiver to recognize its status as a first receiver of a listed food, which might not otherwise be clear in this situation, where the second farm did not originate the food but nonetheless is a farm as defined in proposed § 1.1310." (See 85 FR 59984, 60012.)

III. Processor's Traceability Records

III.a Fresh Processor Scenario Overview

- The next point in this example supply chain is *Fresh Processor*. *Fresh Processor* receives ingredients and processes them to create salad kits made from cherry tomatoes, iceberg lettuce and non-FTL ingredients.
- The companies *Fresh Processor* works with are:
 - Tom's Produce cherry tomato source
 - Lizzie's Lettuce iceberg lettuce grower
 - Food Distributors receives salad kits from Fresh Processor and distributes salad kits to Retailer

III.b Processor's Traceability Program Records, Description of Reference Records

<u>Proposed § 1.1315(a)(1)</u> would require persons subject to subpart S to establish and maintain a description of the reference records in which they maintain the information required under subpart S, an explanation of where on the records the required information appears, and, if applicable, a description of how reference records for different tracing events for a food (e.g., receipt, transformation, shipment) are linked.

<u>Proposed § 1.1315(a)(4)</u> would require persons subject to subpart S to establish and maintain records containing any other information needed to understand the data provided within any required subpart S records, such as internal or external coding systems, glossaries, and abbreviations.

III.g Processor's First Receiver KDEs (kept)

<u>Proposed § 1.1310</u> defines "first receiver" as the first person (other than a farm) who purchases and takes physical possession of a food on the Food Traceability List that has been grown, raised, caught, or (in the case of a non-produce commodity) harvested. As explained in the proposed rule, "A first receiver of a food might be a manufacturer/processor, distributor, or other non-farm entity who receives a food that has been originated." (See <u>85 FR 59984, 60000</u>.) The proposed rule further explained, "Given the wide variety of business models used in the farming community, we believe it will be most efficient to have the first non-farm entity that has purchased and taken physical possession of a listed food—i.e., the first receiver—maintain the tracing information provided by the farm(s) that originated and handled the product." (See <u>85 FR 59984, 60008</u>.)

<u>Proposed § 1.1330</u> would require that, in addition to the records of receipt of foods that would be required under proposed § 1.1335, "first receivers" would also need to establish and maintain certain additional records.

Table 3.g shows the First Receiver KDEs kept by *Fresh Processor* regarding the cherry tomatoes that they receive from *Tom's Produce* and the iceberg lettuce that they receive from Lizzie's Lettuce. As in prior examples, **Table 3g** does not include certain location description information, because *Fresh Produce* chooses to utilize a master file to link such information to the relevant location identifiers.

III.i Processor's Transformation KDEs (kept)

<u>Proposed § 1.1340</u> would require, for each new traceability lot of food produced through transformation, that the person who transforms the food establish and maintain records containing and linking the new traceability lot code of the food produced through transformation to certain information regarding: (1) the food(s) on the Food Traceability List used in transformation and (2) the food produced through transformation._

<u>Proposed § 1.1310</u> would define "transformation" as an event in a food's supply chain that involves changing a food on the Food Traceability List, its package, and/or its label (regarding the traceability lot code or traceability product identifier), such as by combining ingredients or processing a food (*e.g.*, by cutting, cooking, commingling, repacking, or repackaging). The proposed definition further specifies that transformation would not include the initial packing of a single-ingredient food or creating a food.

In this example, **Table 3.i** shows the Transformation KDEs kept by *Fresh Processor* during the production of three finished lots of salad kits using three discrete lots of cherry tomatoes and iceberg lettuce.

As in prior examples, **Table 3.i** does not include certain product description and location description information, because *Fresh Processor* chooses to utilize master files to link such information to the relevant traceability product identifiers and location identifiers, respectively.

III.j Processor's Shipping KDEs (kept and sent)

<u>Proposed § 1.1350(a)</u> would require persons subject to subpart S to establish and maintain records containing specific KDEs related to the shipping of listed foods. In addition, proposed § 1.1350(b)(1) would require that some (but not all) of the KDEs identified in proposed § 1.1350(a) be sent to the immediate subsequent recipient of the food, either in electronic or written form.

Fresh Processor maintains this information in Table 3j.

Each column title in **Table 3.j** indicates whether the data is kept and sent, or simply kept.

Similar to what is described above regarding the shipping KDEs for *Tom's Produce*, **Table 3.j** does not include various product description and location description information. This is because *Fresh Processor* chooses to instead provide relevant entries from their master files, which link the product descriptions and location descriptions to the relevant traceability product identifiers, respectively.

<u>Proposed § 1.1315(a)(4)</u> would require persons subject to subpart S to establish and maintain records containing any other information needed to understand the data provided within any required subpart S records, such as internal or external coding systems, glossaries, and abbreviations.

In this example, *Food Distributors* has opted to maintain a master list of FTL foods received that links the traceability product identifiers for those foods with the corresponding traceability product descriptions. This is shown in **Table 4.e**.

IV.g. Distributor's Shipping KDEs (kept and sent)

<u>Proposed § 1.1350(a)</u> would require persons subject to subpart S to establish and maintain records containing specific KDEs related to the shipping of listed foods. In addition, proposed § 1.1350(b)(1) would require that some (but not all) of the KDEs identified in proposed § 1.1350(a) be sent to the immediate subsequent recipient of the food, either in electronic or written form.

Food Distributor maintains this information in **Table 4.g**.

Each column title in **Table 4.g** indicates whether the data is kept and sent, or simply kept.

Similar to what is described above regarding the shipping KDEs for *Tom's Produce* and *Fresh Processor*, **Table 4.g** does not include various product description and location description information. This is because *Food Distributors* chooses to instead provide relevant entries from their master files, which link the product descriptions and location descriptions to the relevant traceability product identifiers, respectively.

V. Retailer Traceability Records

V.a Retailer Scenario Overview

• The last point in this example supply chain is the retail food establishment, *Retailer*. *Retailer* receives salad kits from *Food Distributors* and sells salad kits to consumers. *Fresh Processor* is the lot code generator for the salad kits.

V.b Retailer's Traceability Program Records, Description of Reference Records

<u>Proposed § 1.1315(a)(1)</u> would require persons subject to subpart S to establish and maintain a description of the reference records in which they maintain the information required under subpart S, an explanation of where on the records the required information appears, and, if applicable, a description of how reference records for different tracing events for a food (e.g., receipt, transformation, shipment) are linked.

Retailer maintains this information in **Table 5.b**.

In this example, *Retailer* has opted to maintain a location master list that links each location identifier that is used in their recordkeeping to the corresponding location description, as shown in **Table 5.c**.
