

Dear Ms. Wisecup:

I write in response to the Warning Letter that Whole Foods Market received from the Food and Drug Administration on December 16, 2020, asserting that Whole Foods Market has engaged in a pattern of receiving and offering for sale certain food products that are misbranded because they do not bear accurate allergen information as required under section 403(w) of the Federal Food, Drug, and Cosmetic Act. I am the Chief Operating Officer of Whole Foods Market, and in that capacity oversee all store operations, including system improvements, process, controls, and procedures. I am also a member of the Whole Foods Market Executive Team. I want to convey that Whole Foods Market takes this issue very seriously. As described in detail below, the company has undertaken and continues to implement, company-wide efforts to improve our ability to ensure that food we sell in all of our retail stores is labeled with accurate allergen information.

We have taken a comprehensive approach to identify the potential causes of allergen-related recalls and the corrective actions that would be most effective in addressing those causes. We have determined that the allergen-related recalls that Whole Foods Market has conducted have occurred for one of two reasons: (1) a system error for our "prepared food products" (those products prepared at an individual retail store), which could include both incorrect information in our data system for a particular ingredient or product, or error at the retail level in preparing and/or labeling a food product for sale in a specific retail store; or (2) a supplier error, where a "supplier-provided finished product" (products received by a retail store already packaged and labeled) is not labeled correctly. We have taken extensive measures to address both of these areas of potential vulnerability, and we have bolstered these actions by centralizing our oversight of retail food safety at the corporate level, which will help ensure consistency across all regions and strengthen our food safety processes and culture.<sup>1</sup>

As background, Whole Foods Market believes customers within different regions around the country have different tastes and needs. We take pride in a region's ability to create different

<sup>1</sup>While the Warning Letter cites five specific recalls, we understand that these recalls were just intended to be examples. We think the actions described in this response would clearly address the causes of those five recalls. However, we have not addressed each recall specifically in this response. Our specific corrective actions for each recall were submitted to the applicable FDA recall coordinator as part of our overall efforts in effectuating each recall. prepared food recipes, procure unique ingredients, and take region-specific initiatives that meet the tastes and needs of customers within their region. While Whole Foods Market still holds these values, we believe that lack of centralized corporate oversight into these decisions led to many of the recalls that we have conducted due to undeclared allergen ingredients. To minimize this risk, over the past few years Whole Foods Market has undertaken a company-wide effort to centralize many functions at a corporate level, including our food safety program, data operations, and oversight of our retail stores. This centralization includes coordinated purchasing and supply chain decisions for foods sold in retail stores and for ingredients used to prepare foods at retail stores, recipe development for retail prepared foods, and development and implementation of and training on centralized food safety processes and procedures, including specifically with respect to allergen management.

Before this centralization effort, certain purchasing, supply chain, and recipe formulation decisions were made at the regional or store level, and some recalls were also effectuated at that level. This means that prepared food recipes, as well as ingredient sourcing and purchasing, may have varied by regions or even individual stores, and product composition was more challenging and complex to track and ensure accuracy. Under the new centralized framework, prepared food recipes will be standardized globally at the corporate headquarters, and purchasing and sourcing decisions will be centrally managed. Each prepared food item will have a single recipe and either a single supply chain for each ingredient or multiple sources of exactly the same ingredient; the data for each item used to generate product labels will also be managed centrally. Further, data regarding already manufactured products that are sold in stores will be managed at a corporate level, as will approval for product suppliers. In Appendix A, we have provided a case study example of how the changes we have made will impact product preparation and information accuracy.

As discussed in more detail below and documented in the attached, we have initiated and are undertaking the following actions:

- 1. Centralized oversight of all retail operations at a corporate level. We created a Vice President position to oversee global retail food safety, and developed and implemented standardized food safety protocols, recipe development processes for foods prepared inhouse, and supplier approval processes.
- 2. Created a global allergen recall task force, which is charged with assessing allergen recalls, identifying any needed process improvements company-wide, and overseeing corrective actions.
- 3. Enhanced our supplier approval program for regionally sourced prepared foods and bakery products. This process is now centralized at the corporate level and conforms to the standards we use to approve suppliers of packaged food products.
- 4. Reviewed and made necessary changes to internal procedures relating to product preparation, label accuracy, and accountability for errors.
- 5. Implemented a policy for the Recipe Execution across all retail locations. This policy increases in-store requirements for adhering to approved recipes for foods prepared inhouse. Our Team Members at each retail location received training in this policy and other enhanced food safety protocols.

- 6. Significantly enhanced our retail audit program. This enhanced audit program includes a retroactive audit, or "clean-up," of our ingredient information, recipe storage, and label generating systems, as well as regular future company-wide audits of the accuracy of recipe and ingredient information.
- 7. Began the roll-out of a Food Safety Accountability Policy that includes compliance with product labeling to ensure that each team member is held to the same food safety requirements and expectations company-wide.

We are confident that these actions will collectively ensure that food products sold in our stores are properly labeled and accurately declare the presence of allergens. We hope this information helps to convey how critical this issue is to Whole Foods Market. We would appreciate the opportunity to meet with you and Mr. Correll, and anyone else appropriate at the agency to discuss our actions in more detail, answer any questions you might have, and receive any feedback on the information that we have provided. We can make our team available at your convenience, and will follow up shortly to schedule this meeting.

### I. Centralized Oversight of Retail Operations and Supplier Approval

As you indicate in the Warning Letter, over the past year, Whole Foods Market has conducted a number of recalls of products that did not properly declare the presence of major food allergens. Our regulatory compliance team and senior food safety leaders identified this as a particular area of concern at the start of 2020, and immediately undertook a number of initiatives at the corporate level to strengthen our allergen controls and our broader food safety system.

In addition, we are in the midst of a multi-year process of centralizing all of our food safety organization and processes, our data operations, our prepared foods system, our data information system, and our supplier approval programs. We believe this centralization and increased corporate oversight will significantly reduce the opportunities for undeclared allergens and other food labeling errors. These centralization efforts have been underway for the past few years and implementation will continue throughout this year. We provide more detail below about the various specific steps we have taken to help strengthen our allergen control program.

### A. Centralizing Food Safety Organization and Processes

We have taken a number of measures to centralize our oversight of food safety, which we believe will broadly ensure consistency across retail locations and allow us to streamline and verify the accuracy of key information. Specifically:

• In October 2019, Whole Foods Market created a new position for Vice President, Retail Food Safety, which is intended to globally oversee food safety in our retail stores. Before this, we did not have a senior corporate position dedicated specifically to oversight of retail food safety. This position is responsible for developing store level Standard Operating Procedures and training programs, investigating in-store safety issues, and ensuring that continuous improvement programs are developed, implemented, and audited. We hired Jeff Edelen, a former leader at The Kroger Co. who was a senior manager in retail food safety and regulatory compliance across 2800+ stores in the United States.

With the creation of this new role, we separated our food safety processes into two components: Retail Food Safety and Supply Chain Food Safety. Our goal in doing this was to allow the newly created Vice President of Retail Food Safety position to focus exclusively on retail operations and the Vice President of Quality and Food Safety position to manage our supply chain. Our Incident Management Team, which is responsible for managing recalls and withdrawals, is part of the Supply Chain Food Safety Team; they identify corrective actions for recalls, including any at the retail level that are ultimately implemented by the Retail Food Safety Team, so that both teams coordinate to ultimately ensure food safety across all Whole Foods Market operations.

• In April 2020, we reorganized the Retail Food Safety Team so that all team members supporting food safety in the regional offices now report directly up to the Vice President of Retail Safety. This centralized all retail food safety oversight and removed direct regional oversight for retail food safety, in order to allow us to focus on common goals company-wide and create more consist retail food safety policies and processes. The Retail Food Safety Team includes three Senior Team Leaders, seven Area Team Leaders, twenty-six Field Food Safety Analysts who report to the Area Team Leaders, a Project Manager, a Data Analyst, and a newly created role of Documentation Manager, in order to continue work to drive SOP clarity, including specific procedures relating to allergen control.

Under this team's leadership, we issued new and updated food safety procedures in July 2020 to be incorporated into daily store operations for all of our retail outlets. These updated procedures included a "Recipe Management Policy," which requires the following steps for any prepared food products in order to help reduce the risk of mislabeled allergen information due to error at the retail level.

- All prepared items must follow a current approved recipe, which is standardized and approved at a corporate level.
- Recipes must be followed precisely and accurately, which is monitored by store leadership.
- Any temporary recipe modifications and substitutions (typically to address an ingredient shortage) that would result in changes to the amount of existing ingredients, changes to the cooking method, or the addition or removal of ingredients require corporate approval, including verification of any revisions to the ingredient statement by the Data Operations Team.
- Production items with multi-ingredients or multi-steps, or those that require cooking, require a batched and printed recipe; any production items with multi-ingredients or multi-steps that do not have a recipe must be formally requested following the Data Operations Team's process, in order to obtain approval at a corporate level.
- All recipes must be current, accurate, printed, and organized.

• Any out-of-date recipes must be removed; this effort is centralized and communicated to individual stores weekly.

### **B. Allergen Recalls Task Force**

In September 2020, we established a global Allergen Recalls Task Force to help us improve specifically in the area of allergen recalls. This group is a cross-functional team consisting of Incident Management, Retail Food Safety, Culinary leadership, Legal, Team Member Services, Retail Operations, Data Operations, Continuous Improvement, and Regional leadership. We assigned this Task Force a project manager and charged it with creating various work-streams to further enhance food safety processes and internal systems to prevent allergen recalls. Since its inception this group has met regarding each Whole Foods Market allergen recall to assess the cause of the recall and any necessary corrective actions, and to prepare and provide reports regarding the recall to regional leadership. This task force is now responsible for allergen recall improvement efforts company-wide.

### C. Enhancing Supplier Approval Program

Our Whole Foods Market private label team (Exclusive Brands) has a well-established program to support supplier and product food safety for private label packaged products sold in our retail stores. We emulated a similar comprehensive program for regionally sourced prepared foods and bakery products in June 2019, as this is the category of supplier-provided products where we identified the most significant errors in ingredient information. The regionally sourced prepared foods and bakery suppliers provide us with branded products that are packed and labeled by the supplier and ready to be placed directly on the shelf. They also provide us with products intended to be transformed, repacked, or used as an ingredient within a store recipe and labeled with a Whole Foods Market brand.

The supplier oversight program is a centrally managed program with dedicated food safety and quality resources. As detailed in our Supplier Approval (Appendix B) and Supplier Facility Risk Assessment (Appendix C) SOPs, review of suppliers consists of a product risk assessment, reviewing each facility's food safety programs including supplier approval procedures, allergen controls, environmental monitoring, sanitation, and label control programs. Historical regulatory performance is taken into consideration, and a passing third-party (b) (4) Food Safety audit is required. In collaboration with business teams, supplier manufacturing sites are enrolled into and approved through (b) (4) Supplier food safety issues, including regulatory non-conformances, withdrawals, and recalls, trigger escalated due diligence, including root-cause analysis, and requirements for corrective and preventive actions. A decision can be made based on risk to determine if an on-site follow-up is needed to assure appropriate control measures have been implemented.

# II. Streamlining Internal Systems and Audit Efforts to Prevent and Detect System Error

As background, we use a system called (b) (4) to host prepared food recipes, which includes specifications for specific ingredients to be used in each recipe. We have now established and implemented new processes so that the centralized Prepared Foods Team develops and approves recipes for all foods prepared in-house, often with input from regional teams, and within (b) (4) each recipe for a food prepared in-house is assigned a PLU code and an

ingredient statement record. Ingredients can only be added to recipes in (b) (4) if they have been approved within our (b) (4) process, our supplier and product management system that houses and maintains food safety supporting information, as meeting all Whole Foods Market ingredient requirements that have been established by our global compliance and food safety teams. Once approved, our centralized purchasing teams generally coordinate ingredient ordering. The Data Monster Recipe Request (Appendix D) flowchart demonstrates the updated steps for initiating and developing a new recipe.

We use (b) (4) as a central location to host all nutrition information, ingredient data, and allergen information for ingredients we use in prepared food recipes. This information is then translated in (b) (4) in order to generate customer facing nutrition and ingredient information. As part of our continuous improvement efforts in food safety, in 2019 we initiated a comprehensive review and clean-up effort to centralize recipe data and reduce information managed at individual retail stores and to ensure that ingredient information is accurate and consistent across all of our internal systems, including (b) (4) (b) (4), and (b) (4) One main objective of this on-going effort is to remove recipes that are no longer in use, primarily because the recipes did not have nutrition data verified or used ingredients that were not purchased through our centralized ordering system. We are doing this to reduce the amount of overall data in our system, which will reduce the risk of retail store employees selecting an incorrect recipe when generating labeling information.

We undertook this review by producing reports for each region with items that we deemed were misaligned and purged the affected data from all systems. Specifically, these reports identified ingredients that were not in the ordering system, recipes that had not yet been approved, recipes in (b) (4) that included ingredients that were not available in the purchasing system, and ingredients that were in the purchasing system and not attached to recipes in (b) (4) By removing this data from our system, we reduced the risk that a recipe that is not actively hosted in (b) (4) could be produced and labeled with outdated information.

Further, as part of the clean-up effort, we enhanced the gatekeeping system for new prepared foods purchase items within (b) (4) (Valid Item One-Pager, Appendix E) to ensure that we have up-to-date ingredients and allergens on all recipes labeled in-house. The workflow required the addition of a nutrition gatekeeping step to ensure purchase items were in (b) (4) No new items for use in prepared foods can be purchased without validating nutrition source and updating ingredients, including allergens, in our recipe database. In addition, no new recipes or PLUs can be created unless all items have a valid nutrition source within (b) (4) Ultimately, this clean-up effort also identified certain products that we determined needed to be recalled due to inaccurate labeling information, which we believe has concentrated the frequency and volume of recalls into a condensed time period over the past year. These efforts were, and continue to be, critical in ensuring that the prepared food products we sell are labeled correctly.

In January 2020, we initiated a project to align all existing purchase items in our recipe database to a nutrition source in (b) (4) We began outreach to all suppliers to upload their ingredient information into (b) (4) Over the past year we have aligned over 5,000 purchase items at the ingredient level between (b) (4) and (b) (4) We are targeting mid-2021 to have all items in (b) (4) aligned to an ingredient record in (b) (4) Previously we did not have a renewal requirement in place, so we often were not notified by the supplier when a product ingredient changed. We now can automatically determine when ingredients used in

foods that we prepare in-house are updated in (b) (4) and update our data systems accordingly, through a status alert that occurs when a product record is changed. This status alert notifies the Compliance Team via a report that will be sent to Data Operations. Data Operations will use that report to assess any changes in the ingredients, including allergens.

To ensure that the streamlined system is working properly, in 2020 the Data Operations Team implemented a company-wide ingredient and allergen audit program. Through this audit program, we compare the information in each product's recipe with the information that is communicated on each product label in order to verify the accuracy of ingredient information, including allergen information, on the product label. We will run this audit annually on every recipe in the database (currently approximately 55,000 recipes) as well as quarterly for new or seasonal products. We will run the quarterly audit before recipes are used to ensure there is a gate to eliminate misalignment of our recipe data system with customer facing ingredients/allergens. We expect that this audit program will eliminate the risk of mislabeling due to misalignment of data between our recipe system and customer-facing ingredient information.

In October 2020, we conducted the first company-wide audit, which identified a number of errors (primarily with recipes that are no longer in use); we corrected each of these errors, which included updating ingredient information as needed. We conducted a second company-wide audit in December 2020 and found no errors, indicating that the ingredient information that we provide consumers for every product we prepare in-house matches the recipes in (b) (4) that are used to prepare the products.

# III. Food Safety at the Retail Level – Recipe Management, Audit, and Accountability

While we have extensively overhauled our food safety processes at the corporate level to help ensure allergen control, we believe it is equally important that such enhancements are implemented down to the retail store level and that our team members understand how best to ensure food safety, especially in regards to allergen labeling. Specifically, team members are required to follow various SOPs when preparing food to ensure the correct ingredients and ingredient labels are being used, including Recipe Execution SOP for Prepared Foods (Appendix F), The Daily Work List (Appendix G), Recipe Execution SOP for Bakery (Appendix H), Food Labeling and Identification Policy (Appendix I), and Food Safety All-in-One User Guide (Appendix J).

As noted above, most critically, in July 2020 we released a new Recipe Management Policy, in addition to new and updated food safety materials to incorporate required food safety protocols into daily store operations.

In addition, in order to centralize the recipe system, we eliminated the ability of individual stores to create their own recipes. We also established a communication escalation process for recipe issues, which supplements the Recipe Execution Policy and is part of the Store Process SOPs. For example, Team Members must execute only one recipe at a time and collect all ingredients prior to starting each recipe. If an ingredient is not available, then the Team Member must immediately notify their leadership. Leadership is only allowed to approve single ingredient substitutions for the same item (e.g., Roma tomatoes for cherry tomatoes). Other ingredient changes (including substituting a different single or multi-ingredient product) must

be escalated to designated regional and global points, who then make recipe and labeling updates using menu and nutritional analysis software. The recipe is not made available for use until the new data is accurately reflected on all recipes, labels, and signs. Finally, to address communication between shifts, Team Members must complete an "Incomplete Production Log" so no one else attempts to make the recipe until the approval process has been completed.

To reinforce these systems, the Global Retail Food Safety Team assigned all store team members and store leadership required allergen training in October 2020, and of those assigned, more than 90 percent have already completed that training; the remainder are expected to complete the training by early this year. As part of the Allergen Job Aid SOP (Appendix K), a team lead or production writer will assign the label and conduct the ingredient verification process for all items produced and packaged in-house. A team member will verify each item made or packaged in-house matches the applicable ingredient information on the following:

- Product signs
- Ingredient labels
- Beauty labels
- Recipes
- Schematics/planograms

In addition, the team member will review the ingredients to make sure the following requirements are met:

- Allergens must be clearly identified:
  - Packaged items must have the label on the packaging.
  - Unpackaged items must have ingredients displayed with the product.
  - Sub-ingredients must be identified [e.g. mayonnaise (expeller pressed canolaoil, eggs, water, honey, distilled vinegar, contains less than 2% of salt, spice, lemon juice concentrate)].
- Allergen information must include the name of the food source:
  - Tree nuts and fish must list the specific species (e.g. Fish Stick Ingredients: Cod, Egg, Milk, Salt)

At that same time, we developed and released a Food Safety Self-Audit Tool for team leadership to reflect on their department's practices and take active managerial control to address potential learning gaps. The Food Safety Self-Audit Tool directs team leadership as follows, "Pick 3 inhouse produced or packaged products and verify the PLU and ingredient list against the recipe used or ingredients on the package." Retail stores that have consistently received satisfactory scores through this tool and through third-party audits facilitated by Everclean are required to perform these self-audits weekly; all other stores must perform a self-audit each day. We

continue to make system improvements by standardizing schematics and planograms, eliminating outdated recipes and PLU data, and evaluating recipe nomenclature for consistency across our company. Finally, we have developed a unified Food Safety Accountability Policy (Appendix L) addressing the responsibilities each team member must uphold to mitigate food safety risk as part of team member duties. This new policy went into effect this month.

\* \* \*

We believe we have taken significant steps in the last two years to streamline and enhance our food safety processes. As we continue to further enhance these processes and accountability mechanisms, we expect to see a reduction in undeclared allergens recalls. By centralizing the system at the corporate level, we have created uniform policies and action items across all our retail stores. With the enhancement to our internal systems and supplier programs, we are confident we will reduce the opportunities for undeclared allergens and mislabeling. Finally, with the Corporate Food Safety Team working directly with regional and store team leadership to take corrective actions, we hope to foster an environment that empowers food safety at the retail level. We will continue to monitor our processes and procedures through our audit program and will assess if any additional actions are needed in the future.
