

State/Local/Tribal Regulators: How do I request an account?	The following is a link to an Account Request form. Depending on your browser settings, you may not be able to view in your browser, but will be able to download the form. Please download, fill it out, and email to the address noted on the form. Pathlore Registration Account Request Form
How do I find my password?	Go to the LMS main page and click the Sign On link in the upper right corner. On the following page click the Reset Password button. Enter your EASE ID/Login ID in the box on the next page, the LMS will send a temporary password to the e-mail address in your profile.
What are the password format requirements?	Passwords must be 8 or more characters, and contain at least one upper case, one lower case, and one special character.
How much does it cost to take online classes?	Online courses in the ORA Pathlore LMS are free.
How can I get a list of all the courses I have taken?	After logging into the LMS choose the Transcript link in the left menu panel.

How do I enroll for online courses?	After locating your desired course, click the 'Start Course' link in the upper right of the screen.
How do I nominate myself for classroom courses?	Locate the class you wish to nominate yourself for through the class search function. When you locate the class click the "select" button next to the class title. Registration options will appear once you are on the class details page. If there is space available in the class the
**NOTE: Self-nomination at this time is restricted to FDA employees. State/Local/Tribal regulators should follow their current procedures to attend a course.	"Nominate yourself for this class" option will appear in the upper right corner of the page.
Will I be notified about my registration?	Yes. An e-mail notification will be sent confirming your registration request. You will receive a follow-up notification when your request is either approved or denied by your Program Training Officer.
Is there a list of online courses?	Learners can search for online courses in the LMS's online Catalog Search. A course search can be done even if you are not logged into the LMS. • Choose Course Search from the left menu panel.

	On the search page choose 'Online Content' from the Delivery Method drop down menu.
Can I pause my training and resume the course from where I left out?	While this is true for most courses, some courses do not have bookmark capabilities and would require re-start.
Are there CEU's associated with the online courses?	Online courses with Continuing Education Units (CEU's) are labeled as appropriate.
How many online courses can I take at a time?	Learners may take as many courses as are available.
Are the fundamental courses targeted towards first time users?	Most available courses specify appropriate target audience.
How do obtain my certificate of completion for an Instructor Led course?	Once you have completed a class an e-mail notification will be sent indicating your successful completion.
