Product information

Intended Use

The Applied Biosystems[™] TaqPath[™] COVID-19 RNase P Combo Kit 2.0 contains the assays and controls for a real-time reverse transcription polymerase chain reaction (RT-PCR) test intended for the qualitative detection of nucleic acid from the SARS-CoV-2 in nasopharyngeal swabs and anterior or mid-turbinate nasal swabs from individuals suspected of COVID-19 by their healthcare provider, as well as from individuals without symptoms or other epidemiological reasons to suspect COVID-19, when tested twice over 2 or 3 days with at least 24 hours (and no more than 36 hours) between tests.

This test is also authorized for use with anterior nasal swab specimens that are collected using the Color COVID-19 Self-Swab Collection Kit with Saline when used consistent with its authorization.

Testing is limited to laboratories certified under the Clinical Laboratory Improvement Amendments of 1988 (CLIA), 42 U.S.C. §263a, that meet requirements to perform high complexity tests.


Results are for the identification of SARS-CoV-2 RNA. The SARS-CoV-2 RNA is generally detectable in upper respiratory specimens during the acute phase of infection. Positive results are indicative of the presence of SARS-CoV-2 RNA; clinical correlation with patient history and other diagnostic information is necessary to determine patient infection status.

Positive results do not rule out bacterial infection or co-infection with other viruses. The agent detected may not be the definite cause of disease. Laboratories within the United States and its territories are required to report all test results to the appropriate public health authorities.

Negative results do not preclude SARS-CoV-2 infection and should not be used as the sole basis for patient management decisions. Negative results must be combined with clinical observations, patient history, and epidemiological information.

The TaqPath[™] COVID-19 RNase P Combo Kit 2.0 is intended for use by qualified clinical laboratory personnel specifically instructed and trained in the techniques of real-time PCR and in vitro diagnostic procedures.

The TaqPath[™] COVID-19 RNase P Combo Kit 2.0 is only for use under the Food and Drug Administration's Emergency Use Authorization.



Product description

The TaqPath[™] COVID-19 RNase P Combo Kit 2.0 is a multiplexed real-time PCR testing solution that can detect the RNA from the SARS-CoV-2 virus and RNase P in a single reaction well.

Each kit includes the following components:

- TaqPath[™] COVID-19 RNase P Kit 2.0—Multiplexed assays that contain primer/probe sets specific to different SARS-CoV-2 genomic regions and primers/probes for human RNase P.
- TaqPath[™] COVID-19 Plus Control—*In vitro* transcribed RNA control that contains templates specific to the SARS-CoV-2 and RNase P regions targeted by the assays.
- TaqPath[™] COVID-19 Control Dilution Buffer—Dilution buffer for the control.

TaqPath[™] 1-Step Multiplex Master Mix (No ROX[™]) must be ordered separately (see "Required materials not supplied" on page 7.

The assay contains primers and probe sets specific to the following targets:

- SARS-CoV-2 N Gene
- SARS-CoV-2 ORF1a
- SARS-CoV-2 ORF1b
- RNase P (human sample collection control)

General laboratory recommendations

- Follow standard operating procedures in your laboratory to prevent contamination, such as the following:
 - Frequent glove changes
 - Frequent decontamination of surfaces, equipment, and pipettes with fresh 10% bleach or decontamination solution, followed by 70% ethanol
 - Use of ultraviolet light during biosafety cabinet decontamination (when available)
- To prevent degradation, keep eluted sample RNA, master mixes, assays, and controls on ice or in cold blocks while in use.
- Limit freeze-thaw cycles.
- Aliquot reagents to prevent stock contamination and reduce the number of freeze-thaw cycles.
- After each run, review the amplification curves for signs of inadequate vortexing or centrifugation.

Assay limitations

- The use of this assay as an *In vitro* diagnostic under the FDA Emergency Use Authorization (EUA) is limited to laboratories that are certified under the Clinical Laboratory Improvement Amendments of 1988 (CLIA), 42 U.S.C. § 263a, that meet requirements to perform high complexity tests.
- The kit performance was established using nasopharyngeal and anterior nasal swab samples only. Specimen types other than nasopharyngeal and anterior or mid-turbinate nasal swabs should not be tested with this assay.
- Clinical performance has not been established with all circulating variants but is anticipated to be reflective of the prevalent variants in circulation at the time and location of the clinical evaluation. Performance at the time of testing may vary depending on the variants circulating, including newly emerging strains of SARS-CoV-2 and their prevalence, which change over time.
- Clinical performance has been established in specimens collected from subjects suspected of COVID-19 or subjects suspected of COVID-19 presenting with one or more symptoms of COVID-19. Performance of specimens collected from individuals without symptoms or other epidemiological reasons to suspect COVID-19 when tested twice over 2 or 3 days with at least 24 hours (and no more than 36 hours) between tests has not been established. A study to determine the performance in individuals without symptoms or other epidemiological reasons to suspect COVID-19 will be completed.
- Samples must be collected, transported, and stored using appropriate procedures and conditions. Improper collection, transport, or storage of specimens may hinder the ability of the assay to detect the target sequences.
- Chemical inactivation and other known clinically relevant interfering substances and techniques can lead to inappropriate primary samples and interfere with test results.
- The workflow must be performed according to the specified methods described in the instructions for use.
- The quality of the biological samples is essential for the quality of the results generated with this kit.
- This kit uses purified RNA as a sample for the analysis. The quality of the RNA recovered from biological samples is essential for the quality of the results generated with this kit.
- Performance was established using the MagMAX[™] Viral/Pathogen II Nucleic Acid Isolation Kit (Cat. No. A48383). Other purification methods may lead to deviations in the expected result.
- Assay performance was established with a maximum of 12 freeze-thaw cycles. Additional freezethaw cycles may result in deviations in the expected results.
- False-negative results may arise from:
 - Improper sample collection
 - Degradation of the SARS-CoV-2 RNA during shipping/storage
 - Specimen collection after SARS-CoV-2 RNA can no longer be found in the specimen matrix
 - Using unauthorized extraction or assay reagents
 - The presence of RT-PCR inhibitors
 - Mutation in the SARS-CoV-2 virus
 - Failure to follow instructions for use
 - Absence of specimen

- False-positive results may arise from:
 - Cross contamination during specimen handling or preparation
 - Cross contamination between patient samples
 - Specimen mix-up
 - RNA contamination during product handling
 - Inconclusive calls may arise from:
 - Sample at concentrations near the limit of detection of the test
 - Assay cross-reactivity with SARS-CoV-1
 - Other factors
- Negative results do not preclude infection with SARS-CoV-2 virus, and should not be the sole basis
 of a patient management decision.
- The impacts of vaccines, antiviral therapeutics, antibiotics, chemotherapeutic or immunosuppressant drugs have not been evaluated. The TaqPath[™] COVID-19 RNase P Combo Kit 2.0 cannot rule out diseases caused by other bacterial or viral pathogens.
- Detection of RNase P indicates that human nucleic acid is present and implies that human biological material was collected and successfully extracted and amplified. It does not necessarily indicate that the specimen is of appropriate quality to enable detection of SARS-CoV-2.

Warnings and precautions

The TaqPath[™] COVID-19 RNase P Combo Kit 2.0 workflow should be performed by qualified and trained staff to avoid the risk of erroneous results. Use separate areas for the preparation of patient samples and controls to prevent false positive results. Samples and reagents must be handled in a biological safety cabinet.

- Samples and controls should always be treated as if infectious and/or biohazardous in accordance with safe laboratory procedures.
- Follow necessary precautions when handling specimens. Use personal protective equipment (PPE) consistent with current guidelines for the handling of potentially infectious samples.
- Always use pipette tips with aerosol barriers. Tips that are used must be sterile and free from DNases and RNases.
- Do not eat, drink, smoke, or apply cosmetic products in the work areas.
- Do not use the kits after the indicated expiry date.
- Dispose of waste in compliance with local, state, and federal regulations.
- · Safety Data Sheets are available upon request.
- · Positive results are indicative of the presence of SARS-CoV-2 RNA.
- Reagents must be stored and handled as specified in "Contents and storage" on page 7.
- Modifications to assay reagents, assay protocol, or instrumentation are not permitted, and are in violation of the product Emergency Use Authorization.
- For Use under Emergency Use Authorization Only.
- For prescription use only.
- For *in vitro* diagnostic use.



Workflow

TaqPath[™] COVID-19 RNase P Combo Kit 2.0 workflow

Extract RNA from patient samples (see Chapter 2, Extract RNA)

Perform automated RNA extraction using the KingFisher[™] Flex Magnetic Particle Processor with 96 Deep-Well Head and the MagMAX[™] Viral/Pathogen II Nucleic Acid Isolation Kit with a 200-µL sample input volume.

Perform RT-PCR

- 1. Prepare RT-PCR reactions (see page 20).
- 2. Perform RT-PCR using one of the following real-time PCR instruments:
 - QuantStudio[™] 5 Real-Time PCR Instrument, 96-well, 0.2-mL block (see page 26)
 - QuantStudio[™] 7 Flex Real-Time PCR System, 384-well block (see page 30)

Analyze data and interpret the results using the Pathogen Interpretive Software (see Chapter 6, Analysis and results)

- 1. Install the appropriate assay panel for your instrument (see page 34).
- 2. Analyze the data (see page 35).
- 3. Review run control results and interpret patient samples (see page 36).

The workflow begins with nucleic acid extraction from nasopharyngeal swab (NP) or anterior or midturbinate nasal swab (NS) specimens that were collected in transport media according to appropriate laboratory procedures.

Nucleic acids are isolated and purified from the specimens using the MagMAX[™] Viral/Pathogen II Nucleic Acid Isolation Kit. Nucleic acid isolation is performed via an automated process using the KingFisher[™] Flex Purification System (KingFisher). For more information about using the kit, see "Related documentation" on page 55.

The nucleic acid is reverse transcribed into cDNA and amplified using the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 and one of the following real-time PCR instruments:

- QuantStudio[™] 5 Real-Time PCR Instrument, 96-well, 0.2–mL block
- QuantStudio[™] 7 Flex Real-Time PCR Instrument, 384–well block

In the process, the probes anneal to specific SARS-CoV-2 target sequences located between unique forward and reverse primers for the following targets:

- SARS-CoV-2 N Gene
- SARS-CoV-2 ORF1a
- SARS-CoV-2 ORF1b
- RNase P (human sample collection control)



During the extension phase of the PCR cycle, the 5' exonuclease activity of Taq polymerase degrades the probe, causing the reporter dye to separate from the quencher dye, generating a fluorescent signal. With each cycle, additional reporter dye molecules are cleaved from their respective probes, increasing the fluorescence intensity. Fluorescence intensity is monitored at each PCR cycle by the real-time PCR instrument.

The data are analyzed, then interpreted by the Pathogen Interpretive Software v1.1.0 and the appropriate assay panel for your instrument.

Guidelines for RT-PCR

Analytical performance of the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 was evaluated by determining limit of detection (LoD), and by characterizing the impact of interfering substances and cross-reactivity, as described in the following sections.

Limit of detection (LoD)

The LoD study with 17.5 µL and 14.0 µL of purified sample RNA established the lowest SARS-CoV-2 viral concentration (Genomic Copy Equivalents or GCE) that can be detected by the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 at least 95% of the time. Banked nasopharyngeal swab (NP) and anterior nasal swab (NS) samples, obtained from U.S. patients in the years 2015-2019 (pooled, respectively, and spiked with gamma-irradiated SARS-CoV-2 isolate USA-WA1/2020 at several concentrations) were processed through the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 workflow. A two-phase approach was used to determine the LoD for each specimen type. A preliminary LoD was established in phase I, and LoD was confirmed in phase II by testing 20 replicates.

Reactivity (Inclusivity)

In silico analysis was executed using 1,802,689 complete SARS-CoV-2 genomes in the GISAID database as of June 09, 2021, which includes the following variants of concern:

- 819,801 genomes of the Alpha variant
- 20,057 genomes of the Beta variant
- 25,068 genomes of the Gamma variant
- 29,149 genomes of the Delta variant

All (100%) SARS-CoV-2 sequences of human origin exhibited 100% homology to one or more primer and probe sets within each of the three targets amplified by the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 (ORF1a, ORF1b, and N Gene), and are thus predicted to be detected.

Interfering substances

Pooled SARS-CoV-2-negative nasopharyngeal swab specimens were spiked with inactivated SARS-CoV-2 at 3 times the limit of detection (225 GCE/mL) and potential interfering substances at the concentrations listed in Table 13. In addition, pooled negative swab specimens without spiked SARS-CoV-2 were spiked with potential interfering substances at the same concentrations. Each substance was tested with triplicate extractions. The results are presented in Table 13.

No false positive or false negative results were observed for any of the substances at the concentrations tested.

In addition to functional testing, an *in silico* study was performed to assess cross-reactivity between the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 primer/probe sequences and the organisms in Table 15, using BLAST analysis. With the exception of SARS-CoV, no bacterial, viral, or fungal microbe sequence aligned with ≥80% identity to more than one TaqPath[™] COVID-19 RNase P Combo Kit 2.0 assay component. The majority of the 285 SARS coronavirus isolates tested in this study shared ≥80% identity with more than one assay component for N gene and ORF1b assays.

Clinical evaluation

A clinical evaluation study was carried out to evaluate the performance of the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 using archived nasopharyngeal swab (NP) and anterior nasal swab (NS) specimens.

The following specimens were tested:

- 60 specimens positive for SARS-CoV-2 (54 nasopharyngeal swabs and 6 anterior nasal swabs)
- 60 specimens negative for SARS-CoV-2 (45 nasopharyngeal swabs and 15 anterior nasal swabs)

Samples were tested using the TaqPath[™] COVID-19 RNase P Combo Kit 2.0 and an FDA EUA-Authorized comparator assay.

Samples were extracted using the MagMAX[™] Viral/Pathogen II Nucleic Acid Isolation Kit for testing with TaqPath[™] COVID-19 RNase P Combo Kit 2.0 and RT-PCR was performed on QuantStudio[™] 5 Real-Time PCR System (96-well, 0.2-mL block) and QuantStudio[™] 7 Flex Real-Time PCR System (384-well) real-time PCR instruments. The comparator method was conducted according to the Instructionsfor Use for the comparator assays.

Positive Percent Agreement (PPA) and Negative Percent Agreement (NPA) were calculated relative to the comparator test. Results are shown below.


