This is to notify you that your request to update the Instructions for Use (IFU) of the NeuMoDx SARS-CoV-2 Assay to; (1) add bronchoalveolar lavage (BAL) specimens to the intended use, (2) modify the intended use to "Testing is limited to laboratories certified under the Clinical Laboratory Improvement Amendments of 1988 (CLIA), 42 U.S.C. §263a, to perform moderate or high complexity tests", (3) update the Clinical Performance section with results from recent testing of clinical specimens, and (4) add minor edits for clarification, is granted.
