- Association of American Feed Control Officials (AAFCO) is a voluntary membership association of local, state and federal agencies charged by their local, state or federal laws to regulate the sale and distribution of animal feeds and animal drug remedies.
- Association of Food and Drug Officials (AFDO) is a regulatory organization that connects food and medical products safety stakeholders and impacts the regulatory environment by shaping sound science-based rules, laws, regulations and sharing best practices that protect public health.
- Association of Public Health Laboratories (APHL) an association that works to strengthen laboratory systems serving the public's health in the U.S. and globally
- Association of State and Territorial Health Officials (ASTHO) is the national nonprofit organization representing public health agencies in the United States, the U.S. Territories, and the District of Columbia, and over 100,000 public health professionals these agencies employ
