

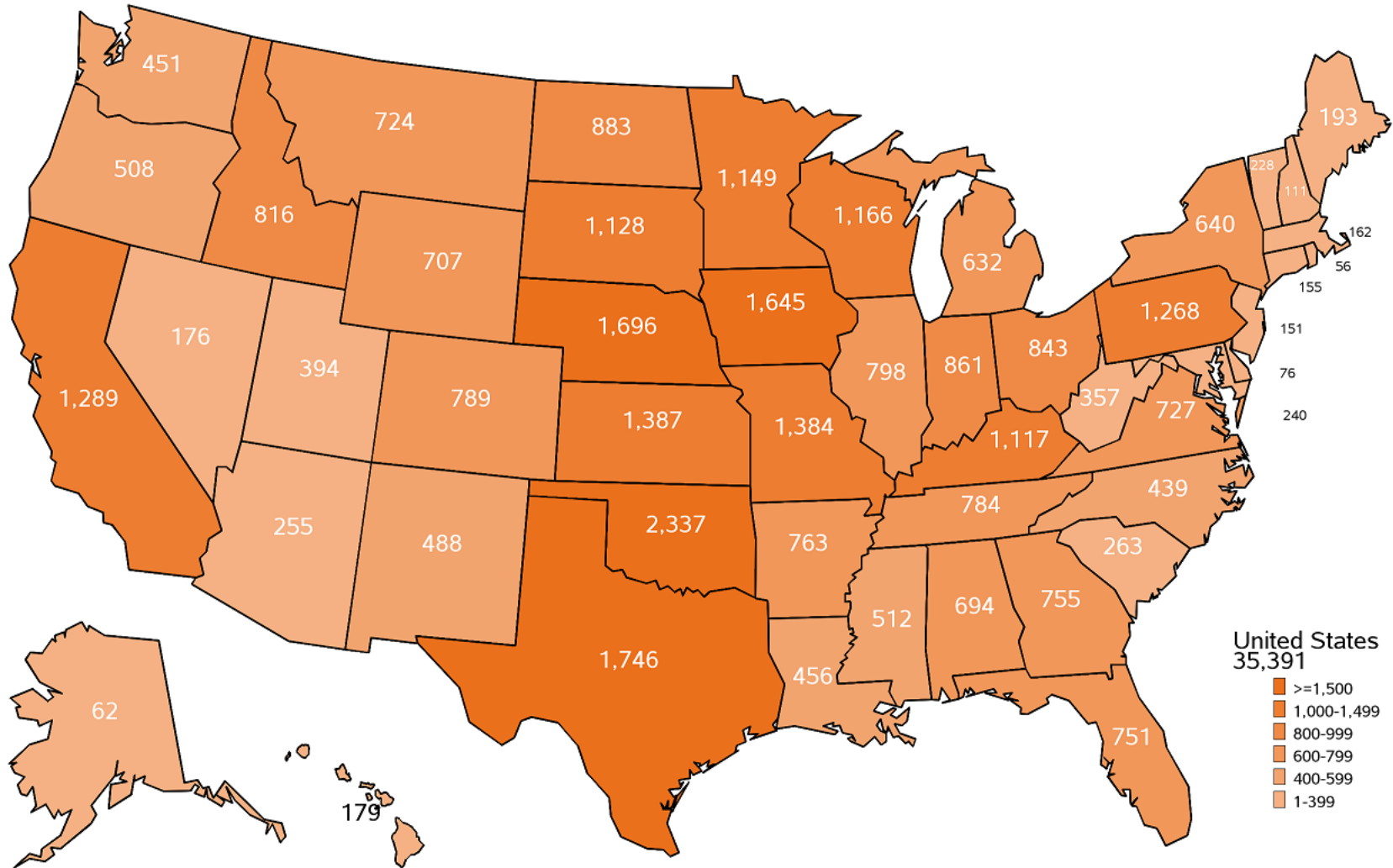

January 2023 Cattle Survey Number of Samples

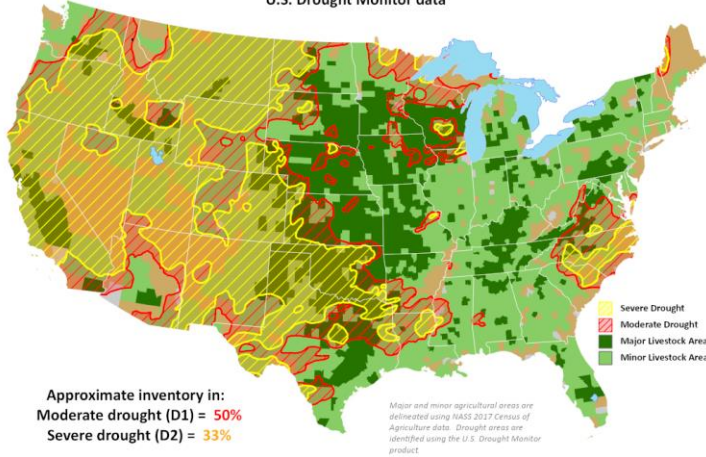


January 2023 Cattle Survey Drought Maps

Cattle Areas in Drought

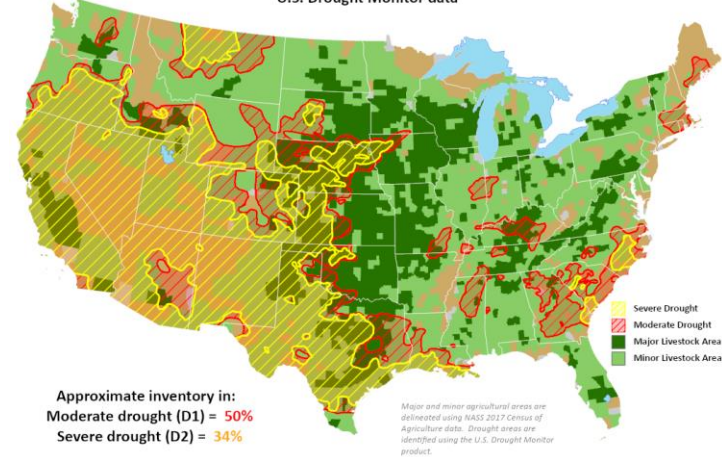

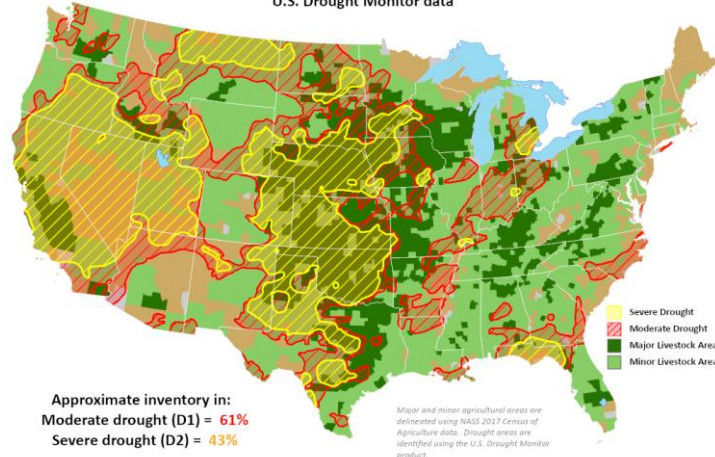

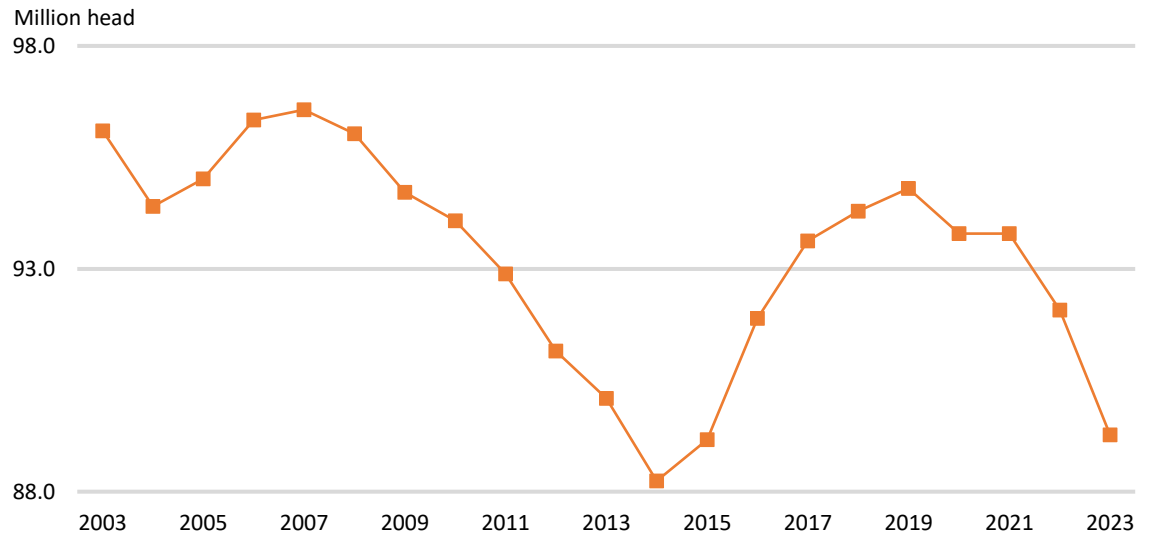

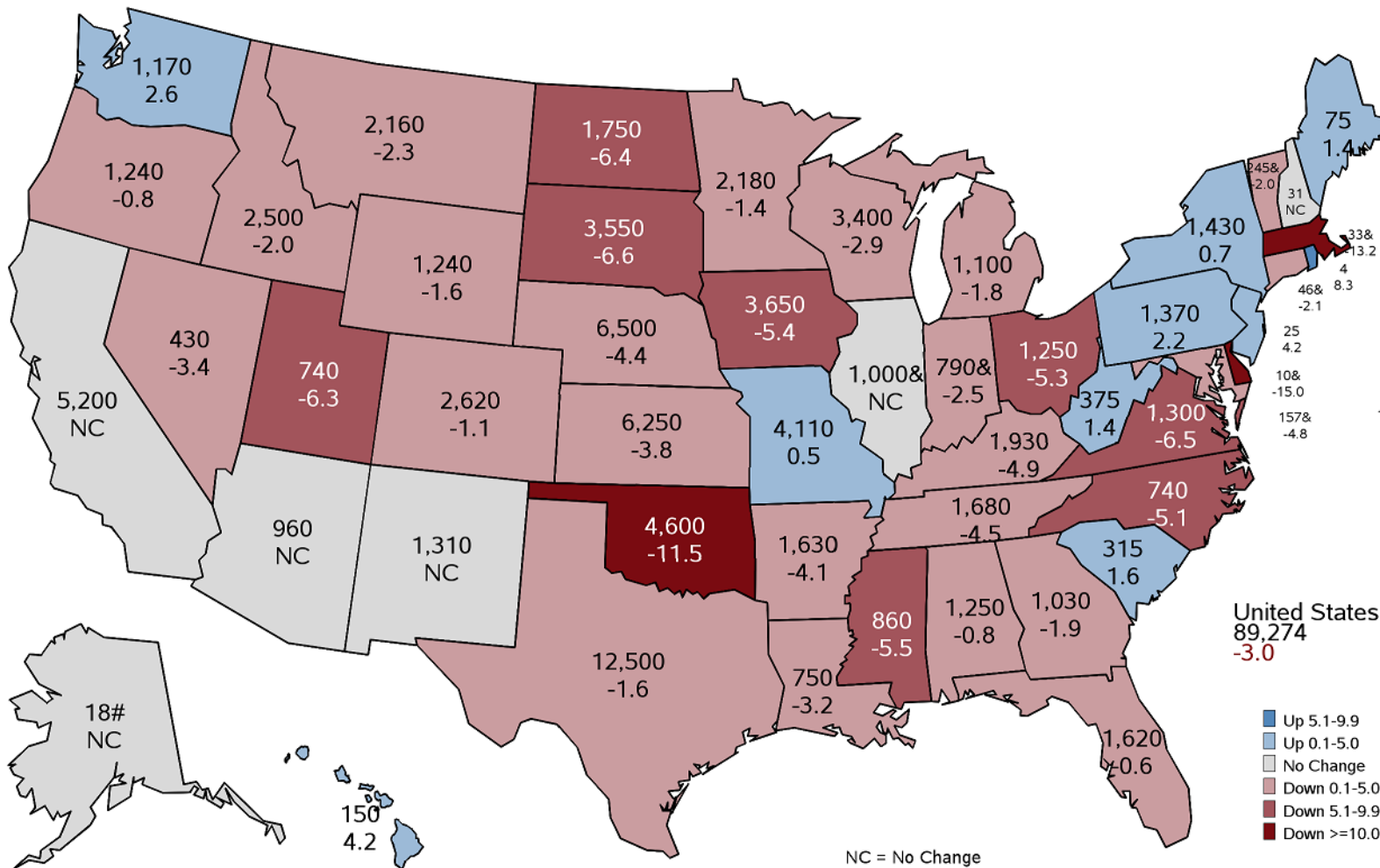

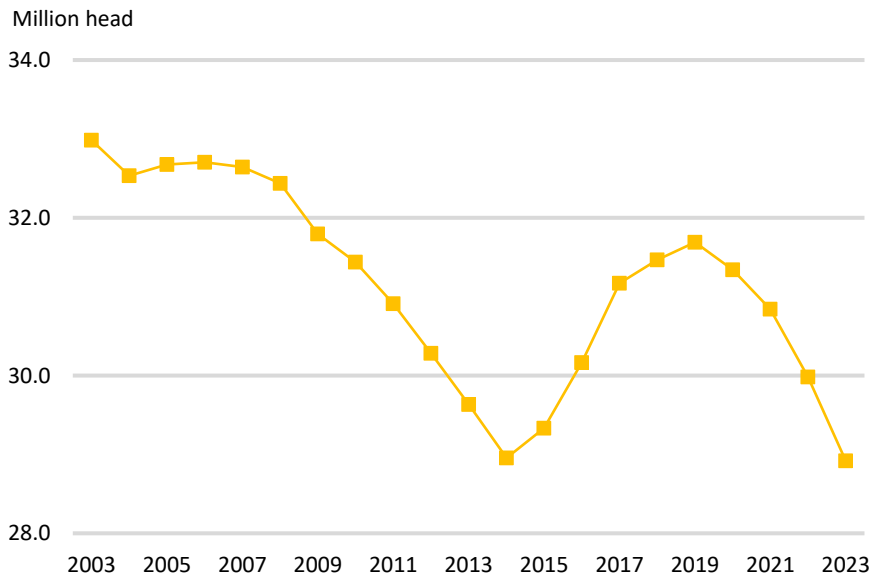

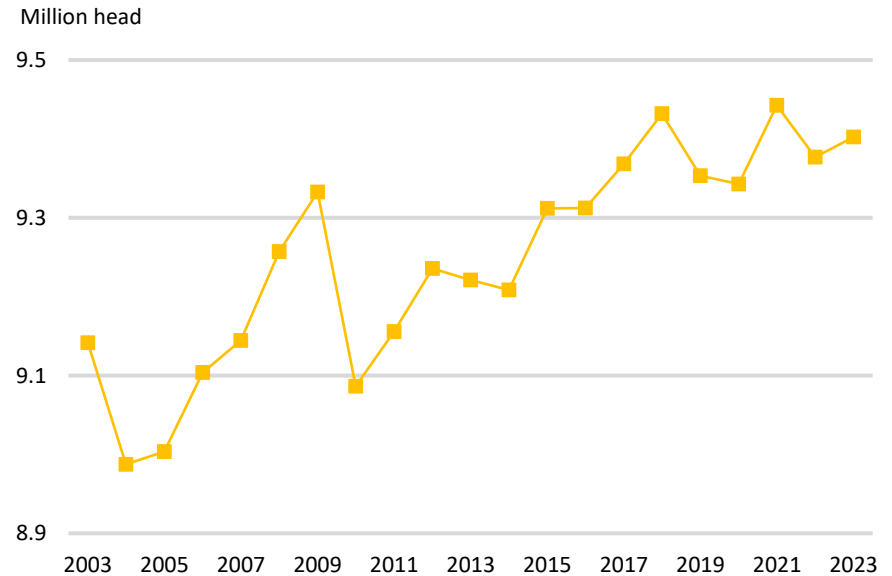

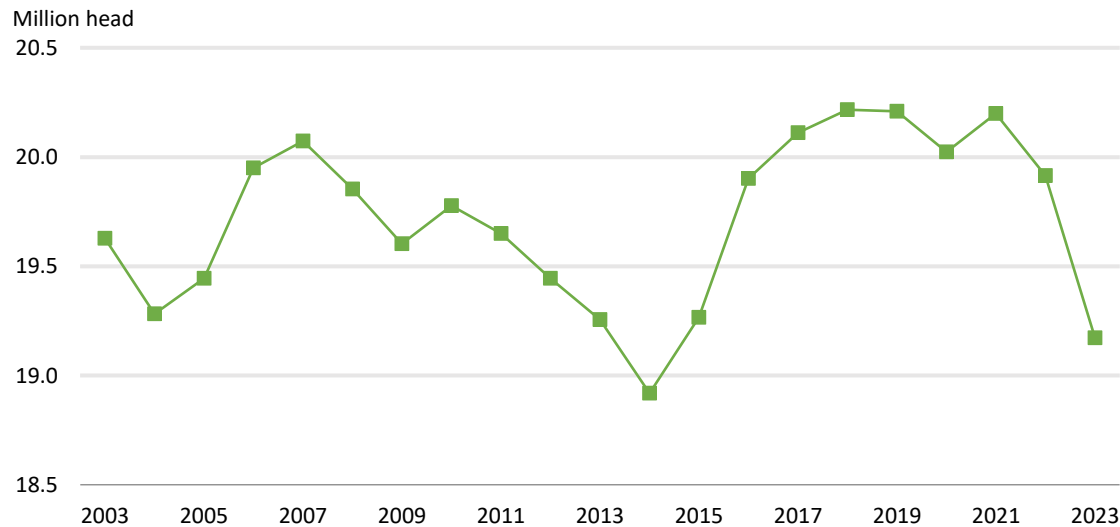

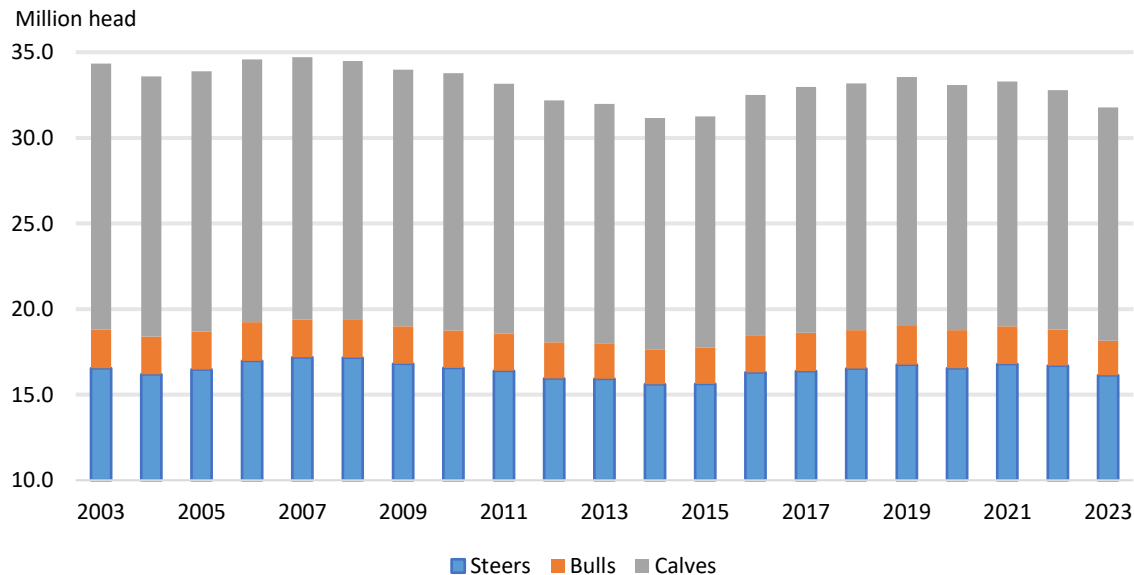

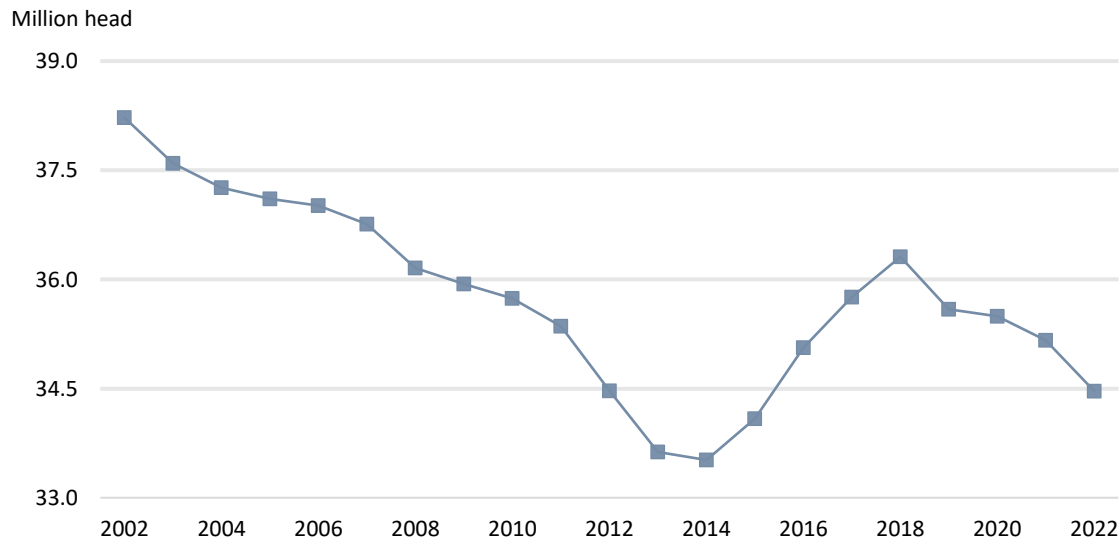


U.S. Calf Crop



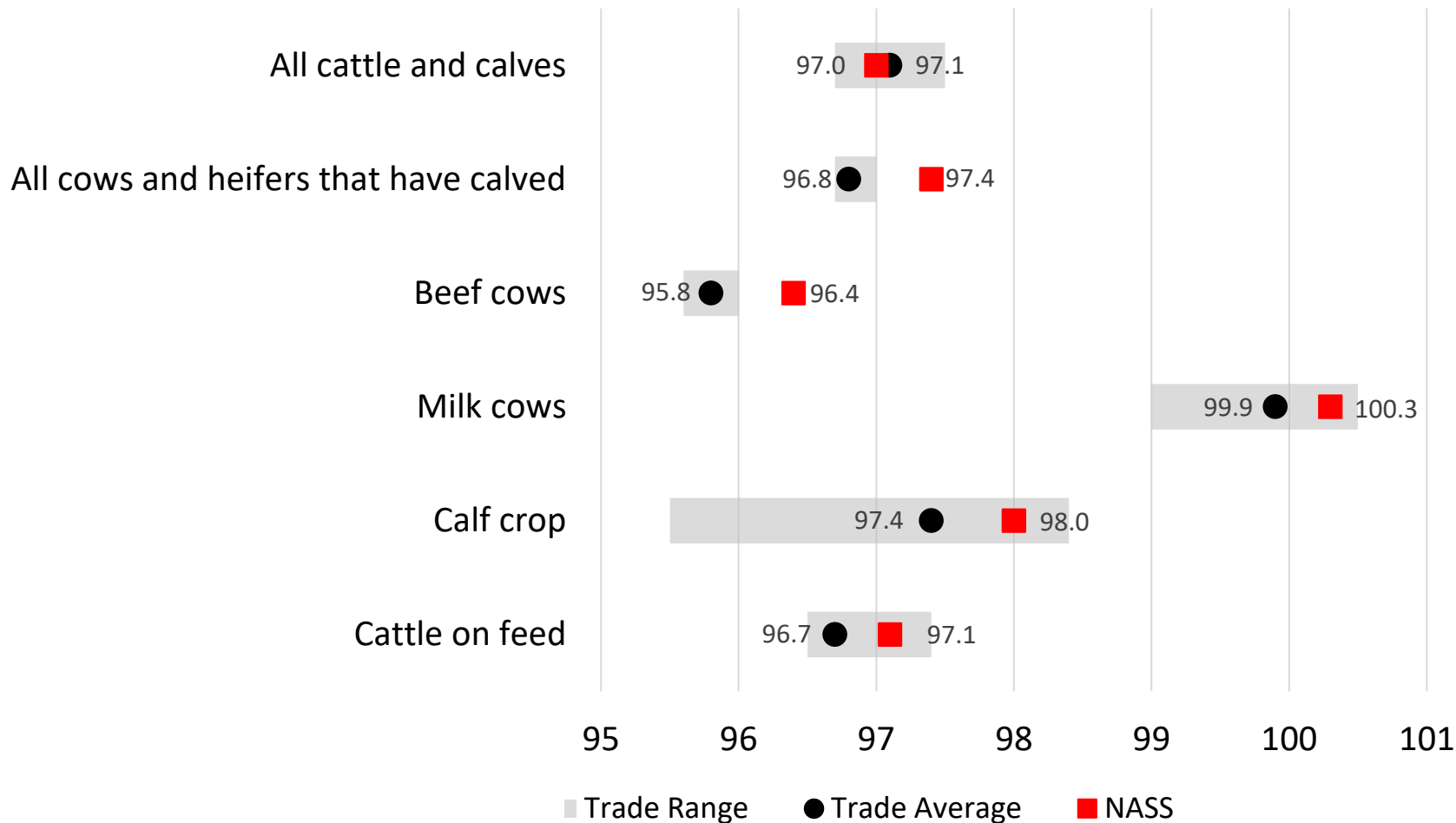

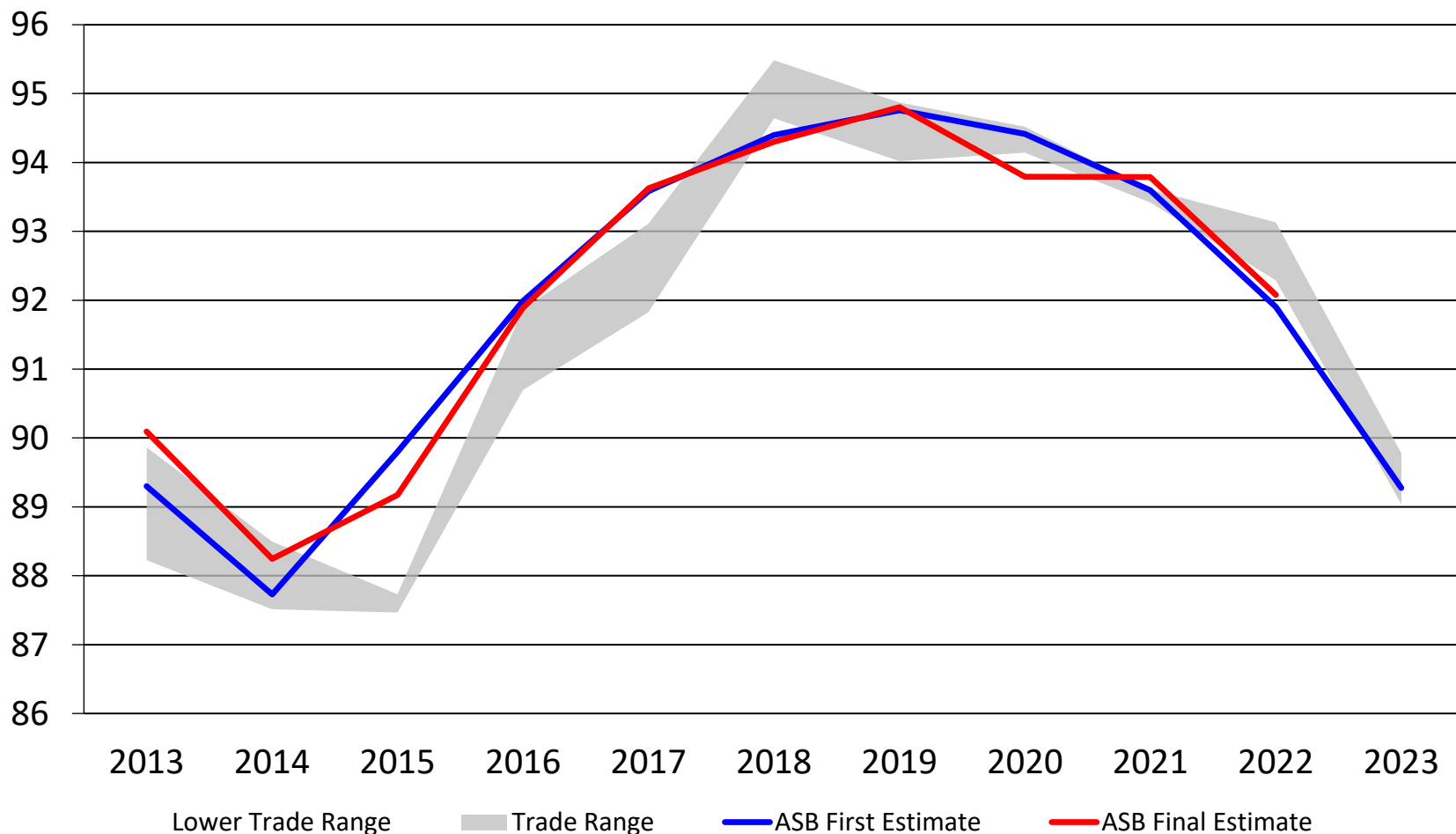


Trade Expectations Compared to NASS Estimates Percent of Previous Year





All Cattle and Calves First Estimate vs Final Estimate

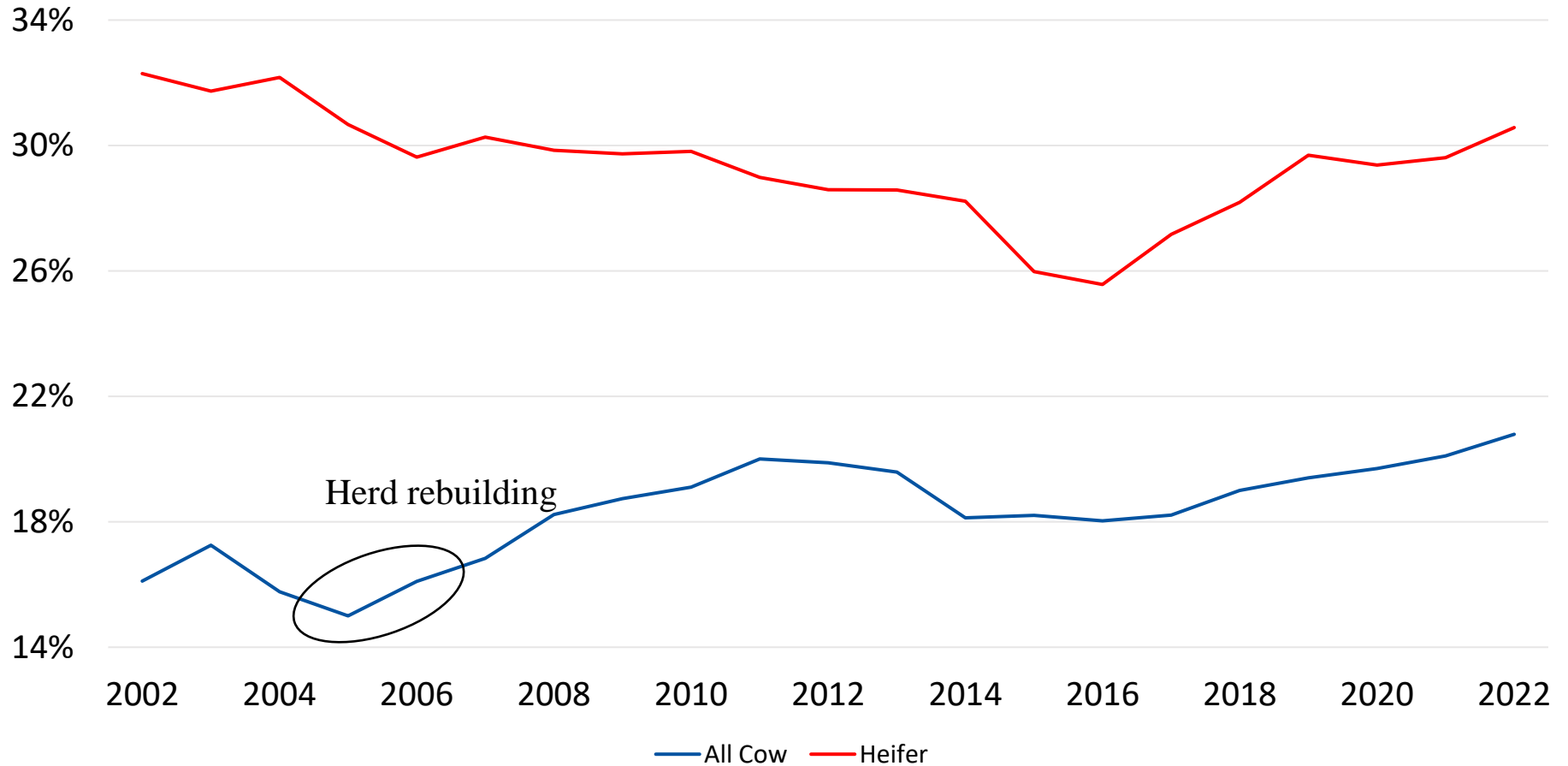




All Cow and Heifer Slaughter as a Percent of Total Slaughter

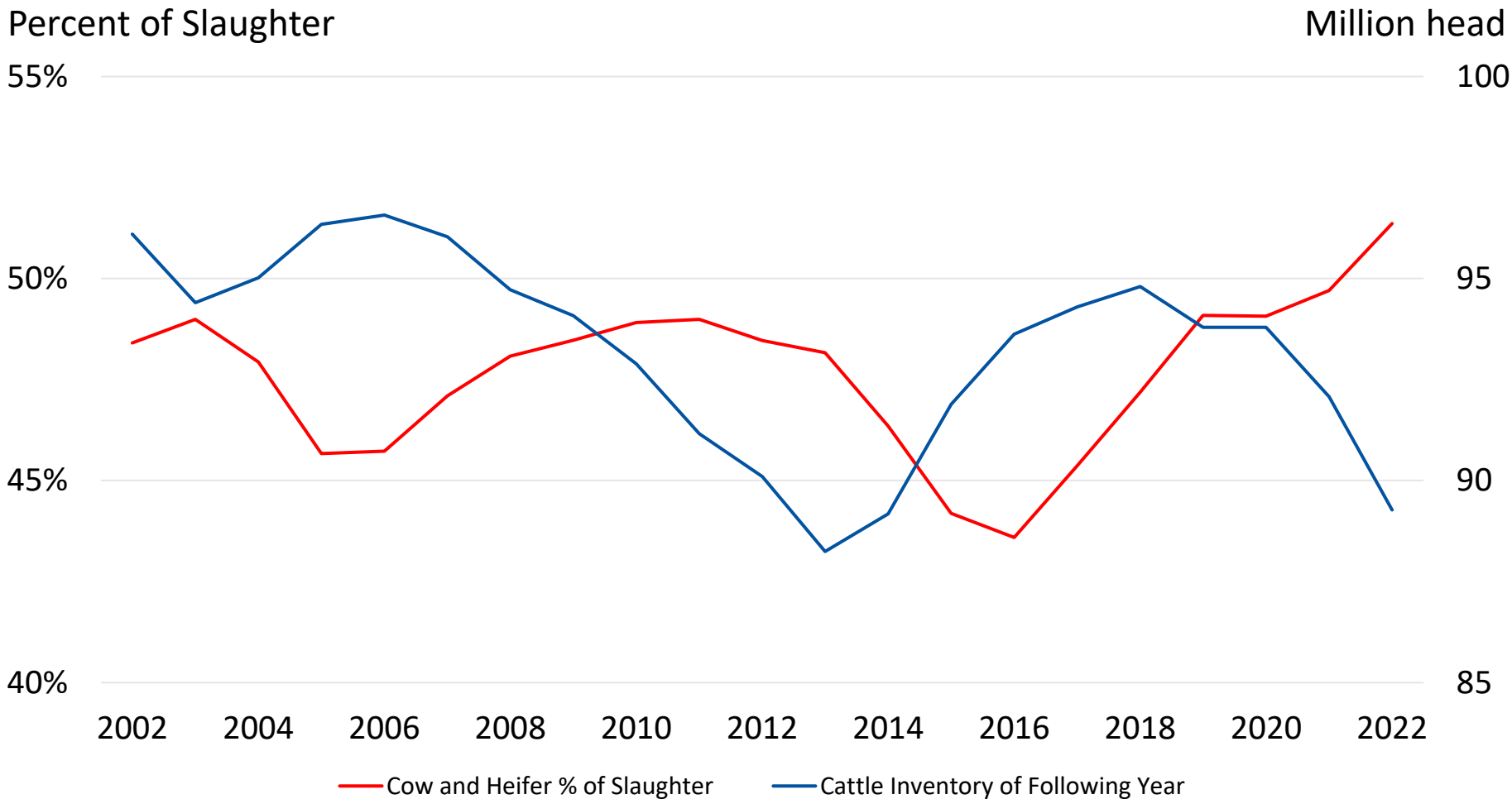


Percent of Slaughter





Cattle Inventory vs Cow and Heifer Slaughter as a Percent of Slaughter



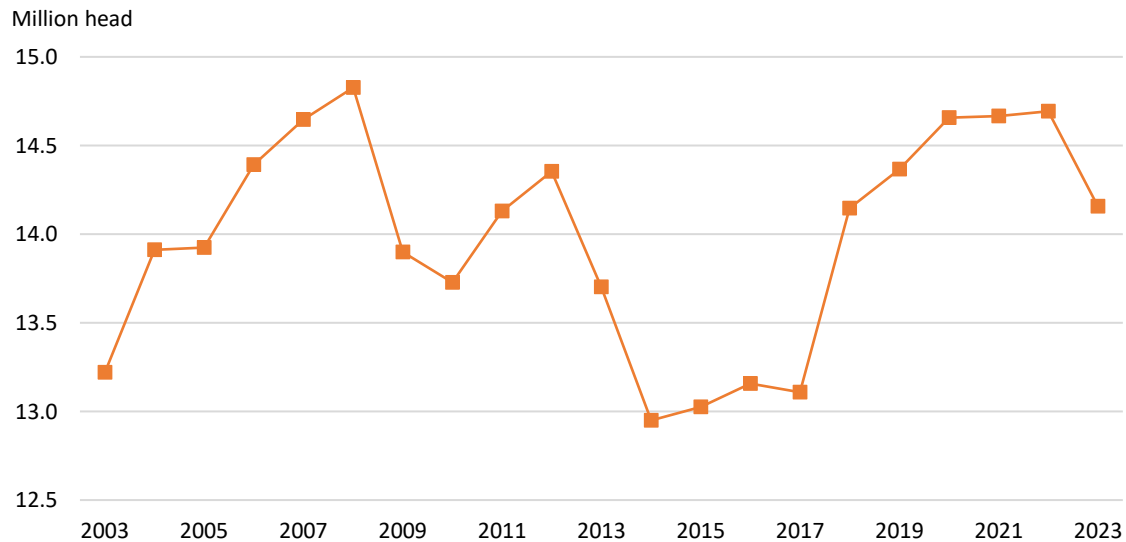

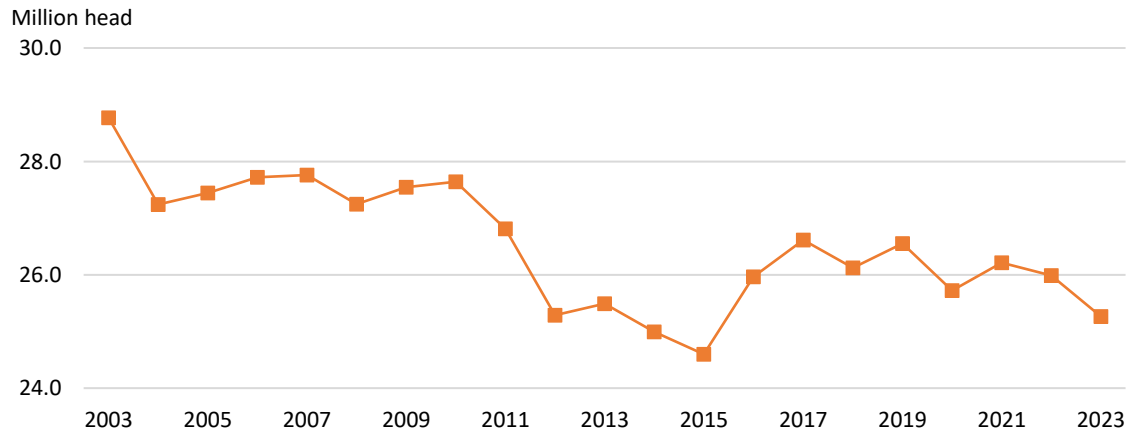

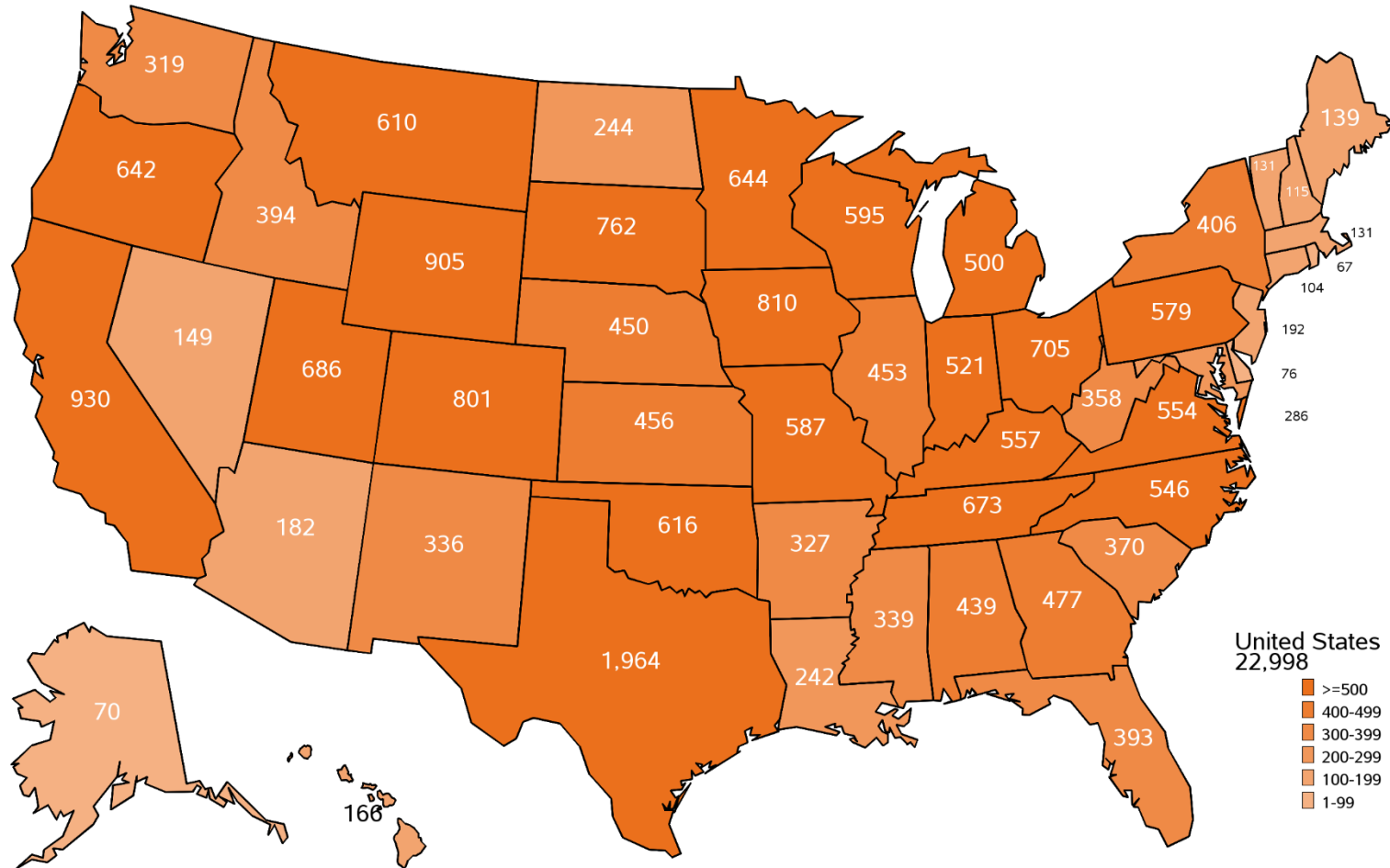

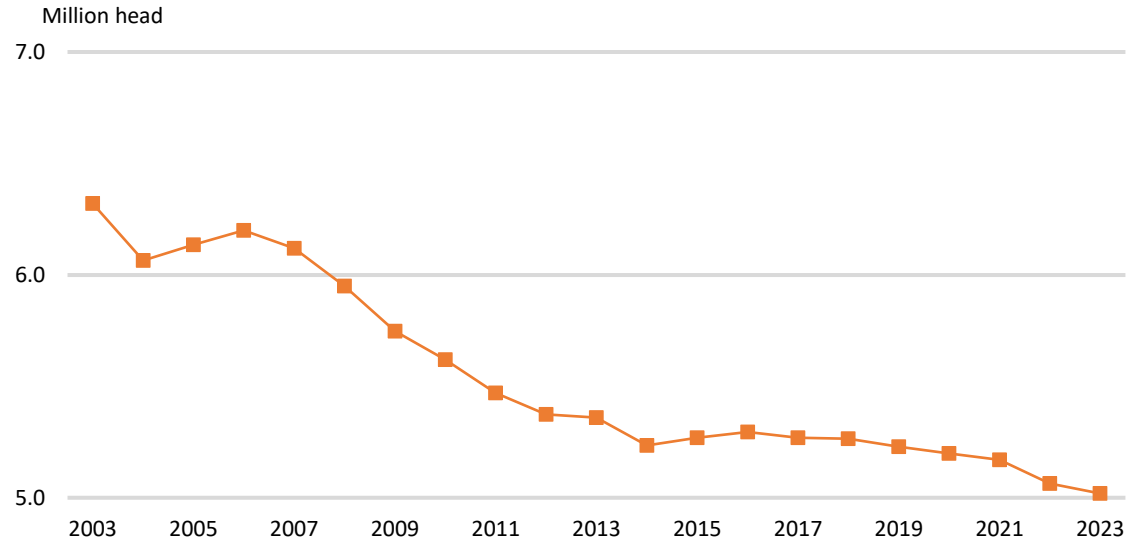

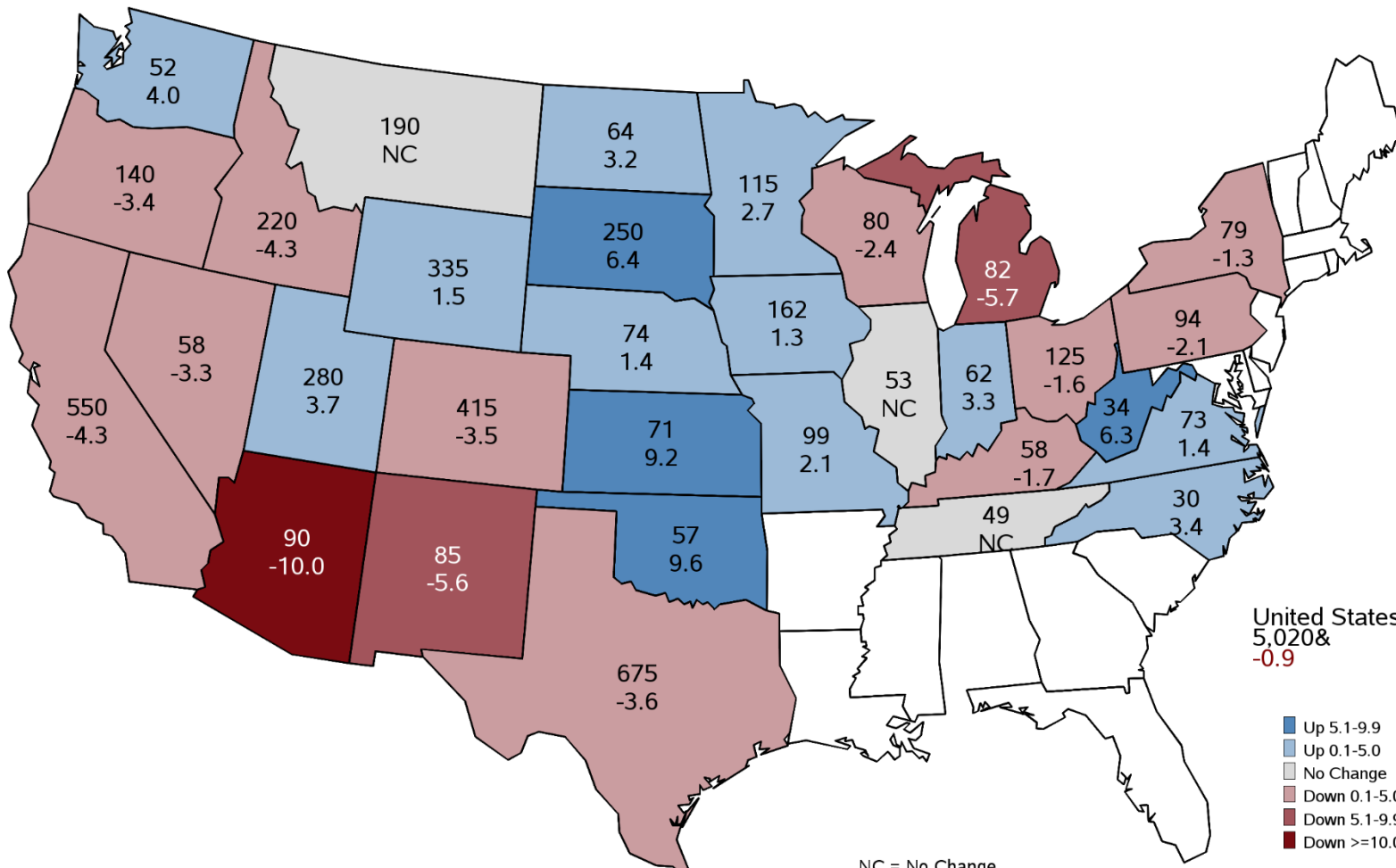

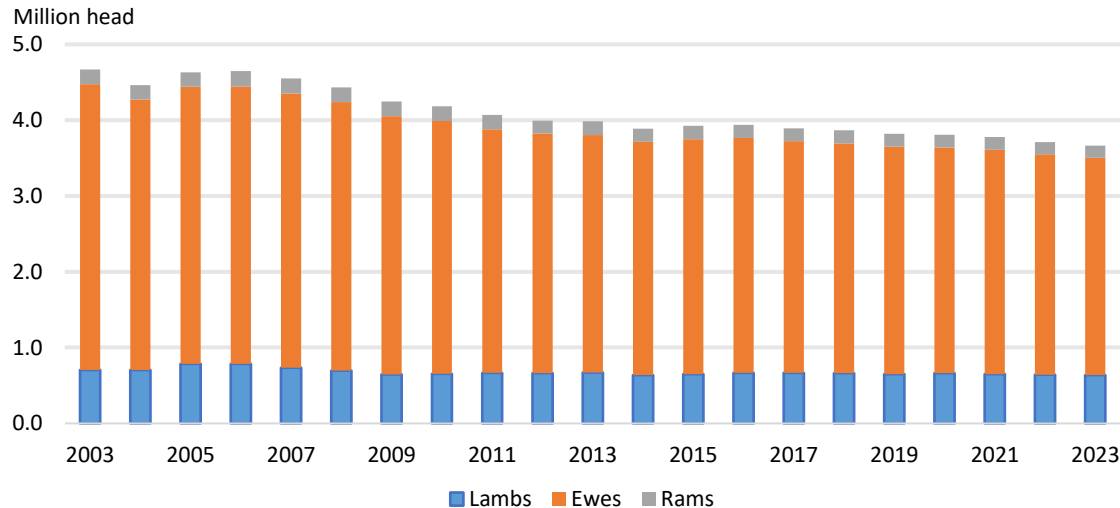

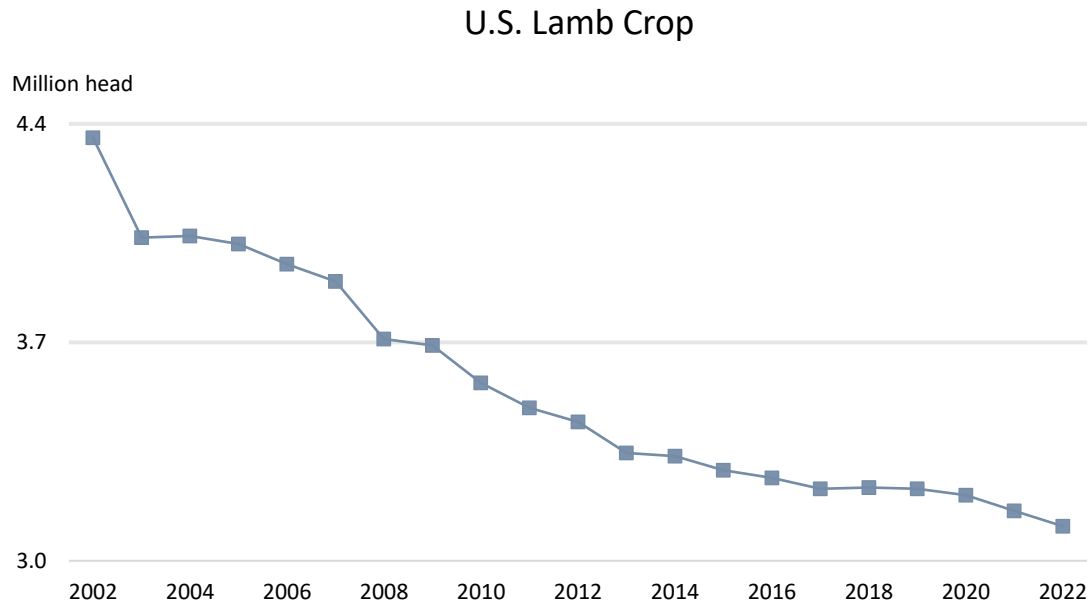

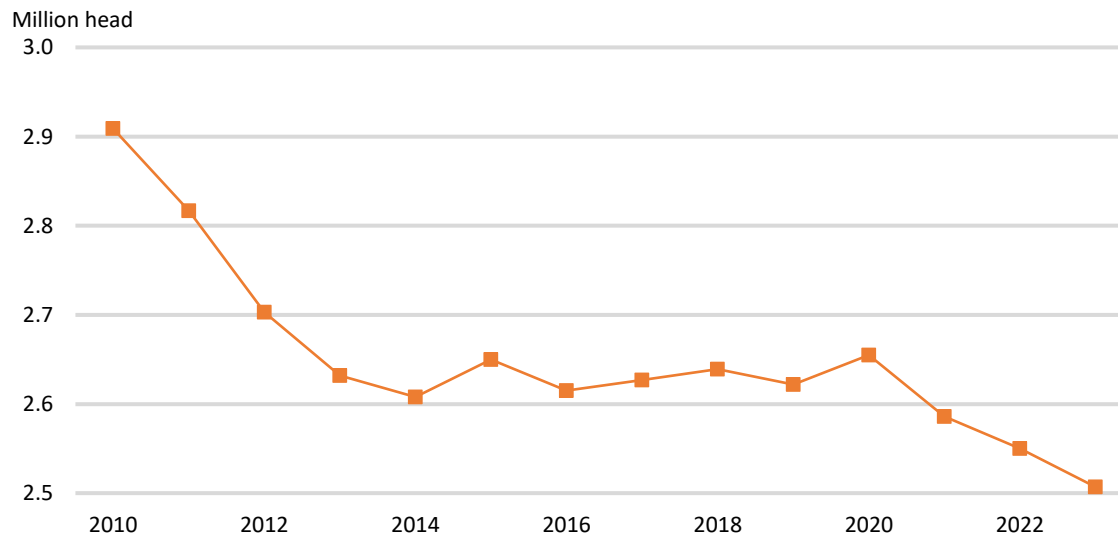

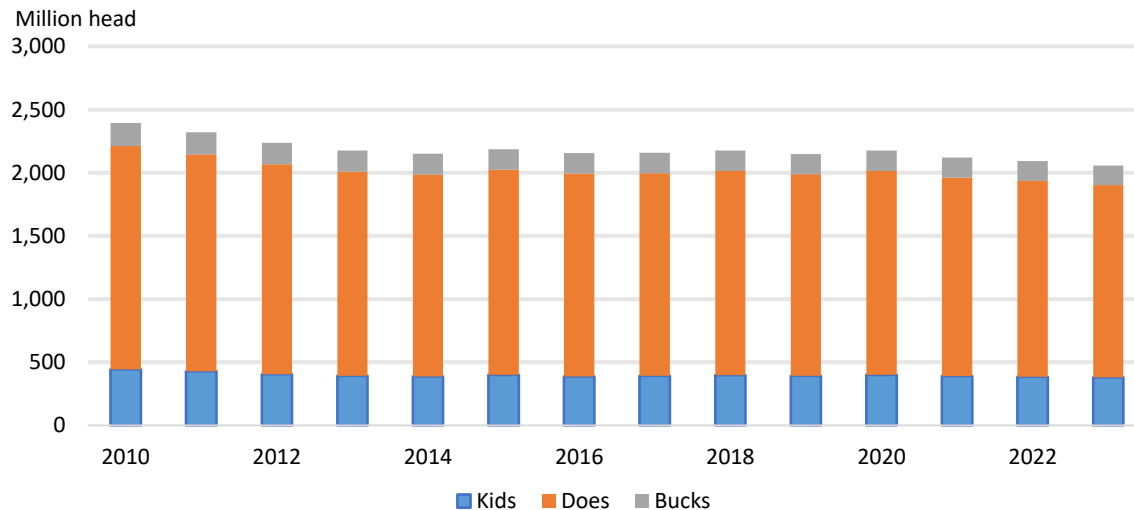

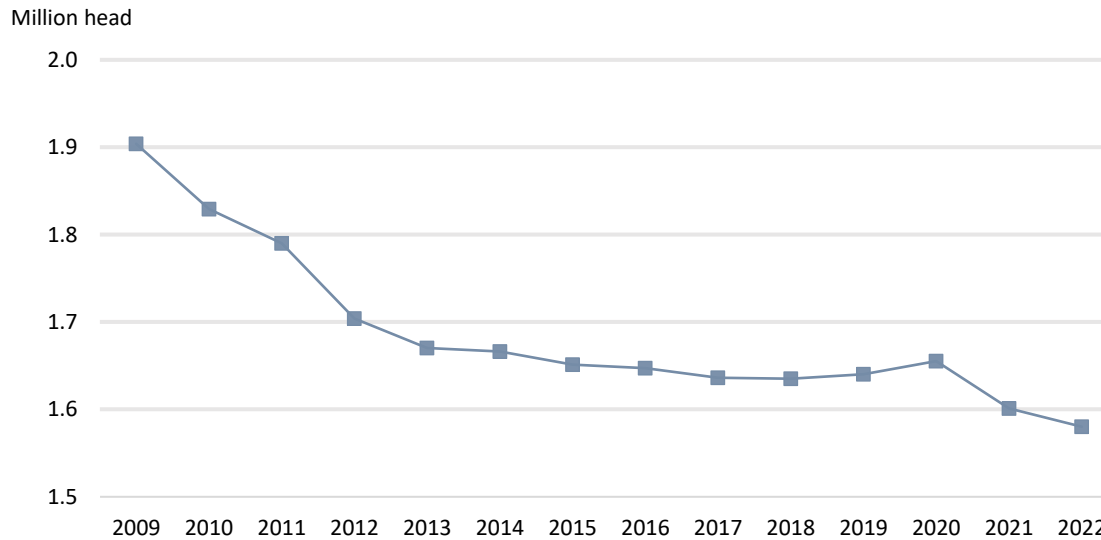
