




Portion of adverse events reported voluntarily through MedWatchin 2020*

Advantages for **Profit**keting Surveillance



Initial account registration for patients, healthcare providers, and industry professionals



USE CASES



A **healthcare provider** uses PrescripChain to report excessive bleeding after administration of Remdisivir to a COVID-19 patient.



A **seizure patient** uses PrescripChain to report anaphylaxis reaction to gabapentin.

USE CASES



An **essential worker** uses **PrescripChain** to report an allergic reaction to the Pfizer BioNTech vaccine.



A **FDA official** uses PrescripChain to analyze a number of allergic reactions to a biosimilar drug and trace it to specific lot number and API.


