This SE Report was inadvertently omitted from the TPL review. For SE0011415, the basis for finding the new tobacco product substantially equivalent is the same as basis listed in the June 26, 2015, TPL review: the product names differ between the new and predicate tobacco products, but the characteristics of the new and predicate tobacco products are the same (i.e., identical characteristics). The SE Report includes all of the information needed by FDA to make an substantial equivalence determination: the predicate tobacco product meets statutory requirements because it is a grandfathered product (i.e., was commercially marketed in the United States as of February 15, 2007), and the new tobacco product is currently in compliance with the FD&C Act.
