1.2. REGULATORY ACTIVITY RELATED TO THIS REVIEW

The Same Characteristics SE Reports were received by FDA on March 9 and 13, 2015. On April 28, 2014, FDA requested additional information from the applicant to uniquely identify the new and predicate tobacco products. In response, the applicant submitted an amendment (SE0011712) on April 29, 2015. On May 8, 2015, FDA requested additional information regarding the Environmental Assessment from the applicant. In response, the applicant submitted amendments (SE0011846 for SE0010989-SE0010997 and SE0011004 and SE0011851 for SE0010959, SE0010960, SE0010961, SE0010965, SE0010966, SE0010975, SE0010976, SE0010980, SE0010981, SE0010985, SE0010986, and SE0010988) on May 18, 2015.

1.3. SCOPE OF REVIEW

This review captures all regulatory, compliance, and scientific reviews completed for these SE Reports.

2. REGULATORY REVIEW

A regulatory review was completed by Grace Kaiyuan on October 6, 2015. The review concludes that each SE Report includes all of the information recommended in the 2015 SE FAQ guidance document for a Same Characteristics SE Report:

1. The SE Reports are identified as “Same Characteristics SE Reports.”
2. The new tobacco products are fully identified and manufactured by the applicant.
3. The predicate products are fully identified and manufactured by the applicant.
4. There is a statement indicating that the applicant intends to market the new and predicate tobacco products.
5. An Environmental Assessment was provided.
6. A health information statement was provided indicating that the applicant will make a health information summary available upon request by any person in accordance with section 910(a)(4) of the FD&C Act.
7. A statement explaining the applicant’s actions to comply with any standards under section 907 of the FD&C Act was provided.
8. An adequate certification statement that was signed by a responsible official who is authorized to act on behalf of the company was provided.

3. COMPLIANCE REVIEW

The Office of Compliance and Enforcement (OCE) completed reviews to determine whether the applicant established that the predicate tobacco products are grandfathered products (i.e., were commercially marketed as of February 15, 2007). The OCE reviews dated April 13, 14, and 17, 2015, conclude that the evidence submitted by the applicant is adequate to demonstrate that the predicate tobacco products are eligible predicate tobacco products based on a cross-reference to previously finalized standalone grandfathered reviews of the same products.

OCE also completed a review to determine whether the new tobacco products are in compliance with the Federal Food, Drug, and Cosmetic Act (FD&C Act), as required by section 905(j)(1)(A)(i) of the FD&C Act. The OCE review dated September 23, 2014, concludes that the new tobacco products are in compliance with the FD&C Act.

4. SCIENTIFIC REVIEW

Scientific review was not initiated by the Office of Science (OS) because the characteristics of the new and corresponding predicate tobacco products are the same (i.e., the new and predicate products have identical characteristics). Therefore, scientific review is unnecessary.

5. ENVIRONMENTAL DECISION

A finding of no significant impact (FONSI) was signed by Kimberly Benson, Ph.D. on August 28, 2015. The FONSI was supported by an environmental assessment prepared by FDA on August 28, 2015.

6. CONCLUSION AND RECOMMENDATION

In all SE Reports, the product names differ between the new and corresponding predicate tobacco products, but the characteristics of the new and corresponding tobacco predicate products are the same, meaning identical in characteristics. The SE Reports include all of the information needed by FDA to make a substantial equivalence determination.

The predicate tobacco products meet statutory requirements because they are grandfathered products (i.e., were commercially marketed in the United States as of February 15, 2007).

All of the new tobacco products are currently in compliance with the FD&C Act. I concur with these reviews and recommend that SE order letters be issued.

FDA examined the environmental effects of finding these new tobacco products substantially equivalent and made a finding of no significant impact.

SE order letters should be issued for the new tobacco products in SE0010959, SE0010960, SE0010961, SE0010965, SE0010966, SE0010975, SE0010976, SE0010980, SE0010981, SE0010985, SE0010986, SE0010988-SE0010997, and SE0011004, as identified on the cover page of this review.
