1. BACKGROUND

1.1. NEW AND ORIGINAL PRODUCTS

The applicant submitted information for the new and original products listed in detail in the Appendix.

1.2. REGULATORY ACTIVITY

See appendices for products and amendments.

1.3. SCOPE OF REVIEW

This review captures all compliance, regulatory, and scientific reviews completed for the new products that are the subject of this review.

2. COMPLIANCE REVIEW

For EX0001377-PD1 – EX0001382-PD1 and EX0001389-PD1 – EX0001391-PD1, the Office of Compliance and Enforcement (OCE) completed a review to determine whether the applicant established that the original products are grandfathered products (i.e., were commercially marketed in the United States as of February 15, 2007). The OCE reviews dated March 10, 2021 and March 12, 2021, concludes that the evidence submitted by the applicant for EX0001377-PD1 - EX0001382-PD1, EX0001389-PD1 and EX0001391-PD1 respectively, is adequate to demonstrate original products are grandfathered products. For EX0001387-PD1, EX0001390-PD1 and EX0001388-PD1, the original products in SE0000068 and SE0000067, respectively, were determined to be substantially equivalent and in compliance with the Federal Food, Drug, and Cosmetic Act (FD&C Act) by FDA. Therefore, the original products are eligible for modification under the Exemption Request pathway.³

3. TOBACCO ADDITIVE MODIFICATION

The applicant claims that the modifications of the original products compared to the corresponding new products are the result of:

deleting additives (tipping paper adhesive and filter tow) in EX0001377-PD1 –
 EX0001382-PD1, EX0001389-PD1, and EX0001391-PD1

- adding additives (tipping paper adhesive and filter tow) in EX0001377-PD1 EX0001382-PD1, EX0001389-PD1, and EX0001391-PD1
- deleting an additive (Fire Standards Compliant (FSC) cigarette paper) in EX0001387-PD1
 EX0001388-PD1, and EX0001390-PD1
- adding an additive (FSC cigarette paper) in EX0001387-PD1, EX0001388-PD1, and EX0001390-PD1
- increasing the quantities of existing additives (tipping paper adhesive and cork tipping paper) in EX0001387-PD1 – EX0001388-PD1, and EX0001390-PD1
- deleting additives (filter center line adhesive, filter sideseam adhesive, cigarette sideseam adhesive, cork tipping paper, non-porous plug wrap, gold monogram ink on the cigarette barrel, and blue monogram ink on the cigarette barrel) in EX0001389-PD1 and EX0001391-PD1
- adding additives (filter center line adhesive, filter sideseam adhesive, cigarette sideseam adhesive, cork tipping paper, and non-porous plug wrap) in EX0001389-PD1 and EX0001391-PD1

4. SCIENTIFIC REVIEW

The review finds these modified ingredients (see Section 3) are additives because their intended use may reasonably be expected to result, directly or indirectly, in their becoming a component or otherwise affecting the characteristics of the products. The review concludes that the modifications are minor modifications of a product in accordance with section 905(j)(3)(A)(i) of the FD&C Act.

5. ENVIRONMENTAL DECISION

The final environmental review found that the applicant did not provide complete market volume information for the new or original products. Therefore, additional information is needed to determine whether to prepare an environmental impact statement (EIS) or a finding of no significant impact (FONSI).

6. CONCLUSION AND RECOMMENDATION

I concur with the conclusion of the scientific review that these modifications (see Section 3) are minor modifications of a product in accordance with section 905(j)(3)(A)(i) of the FD&C Act. I concur that the modified ingredients are "additives" as defined in section 900(1) of the FD&C Act. In addition, it is my conclusion that, consistent with section 905(j)(3)(A)(ii) of the FD&C Act, an SE Report is not necessary to ensure that permitting the new products to be marketed would be appropriate for the protection of the public health. For EX0001387-PD1 – EX0001388-PD1, and EX0001390-PD1, the review identifies that the applicant intends to delete the original FSC cigarette paper and add an alternate FSC cigarette paper. There are minor differences in the levels (b) (4) (b) (4) an (b) (4) e in the FSC cigarette paper between the new and original products. However, these differences are not expected to have a significant impact on the product performance or HPHC yields. For EX0001377-PD1 – EX0001382-PD1, EX0001389-PD1, and EX0001391-PD1, the applicant proposes to delete the filter tow and add an alternate filter tow which is a minor modification and is not expected to materially affect any other characteristic (materials, ingredients, design, composition, heating source, or other features) of the product.

Because the filter tows are not combusted, volatilized, or otherwise released during normal cigarette consumption, the modifications of ingredients in the filter tow are not expected to significantly alter the smoke chemistry and consumer exposure to chemical constituents from the filter tow while smoking. For EX0001377-PD1 — EX0001382-PD1, EX0001389-PD1, and EX0001391-PD1, the applicant intends to delete various adhesives (tipping paper adhesive, filter center line adhesive, filter sideseam adhesive, or cigarette sideseam adhesive) in the original products and the addition of an alternate adhesives (tipping paper adhesive, filter center line adhesive, filter sideseam adhesive, or cigarette sideseam adhesive) in the new products is a minor modification. These adhesives are not combusted, volatilized, or otherwise released during normal cigarette consumption, therefore the ingredient differences and relatively small increase in content between these adhesives of the new and original products are not expected to significantly alter the relative smoke chemistry or consumer exposure to chemical constituents of the new products relative to the original products. For EX0001387-PD1 – EX0001388-PD1, and EX0001390-PD1, there are also in increase in the tipping paper adhesive, however, as stated above, the ingredient differences and relatively small increase in content between in the tipping paper adhesive of the new and original products are not expected to significantly alter the relative smoke chemistry or consumer exposure to chemical constituents of the new products relative to the original products. EX0001389-PD1 and EX0001391-PD1, the applicant proposed the deletion of white tipping paper and the addition of white tipping paper, which is not expected to have any significant effects on product chemistry or consumer perception as outlined in the May 16, 2017 social science memo. The applicant also intends to increase the tipping paper resulting in a slight increase in length of EX0001387-PD1 — EX0001388-PD1, and EX0001390-PD1 which is not intended, nor is it expected, to materially affect any other characteristic (materials, ingredients, design, composition, heating source, or other features) of the product. For EX0001389-PD1 and EX0001391-PD1, the applicant proposes the deletion of plug wrap and the addition of an alternate plug wrap. The plug wraps between the new and original products contain minimal differences in the additives that compose the plug wraps. In addition, there is no change in the perforation during manufacturing, meaning the plug wraps are non-porous in the original and new products. These minor differences are not expected to have a significant impact on product performance or HPHCs (e.g., tipping paper and filter tow), and is considered a minor modification. Finally, for EX0001389-PD1 and EX0001391-PD1, the applicant intends to delete the monogram ink (gold and blue) on the cigarette barrel which is a minor modification and this removal of the monogram ink is not expected to materially affect any other characteristic (materials, ingredients, design, composition, heating source, or other features) of the products and may potentially decrease HPHC yields. Lastly, I find that an exemption for these modifications is otherwise appropriate as required by section 905(j)(3)(A)(iii) of the FD&C Act. Therefore, the new tobacco products should be found exempt from the requirements of substantial equivalence under section 910(a)(3)(A) of the FD&C Act.

The original products are eligible for modification through the Exemption Request pathway because they can be legally marketed in the United States. The original products are grandfathered products; i.e., were commercially marketed in the United States as of February 15, 2007, or previously found SE and in compliance with the FD&C Act by FDA.

FDA has examined the environmental effects of finding these new products exempt from substantial equivalence and found that additional information is necessary to determine the impact of the action. Without this information, FDA may be precluded or delayed from issuing an EX order.

An Environmental Information Request letter should be issued requesting the following information:

 All of your EX Requests lack sufficient market volume information for the original and new products. Marketing information is used to quantitatively assess the environmental impact of manufacturing, use, and disposal of the new products as compared to the original products. Provide the current market volume for the original products and the first- and fifth-year projected market volume for the original products in the Table below.
