EUA yog tau kev txhawb los ntawm Neeg Tuav Ntaub Ntawv Txog Kev Noj Qab Hauv Huv thiab Cov Kev Pab Pej Xeem) (Secretary of Health and Human Services) (HHS) cov lus plov meej tias cov xwm txheej uas muaj yeej kub ceev tsim nyog siv cov tshuaj thiab cov khoom roj ntsha thaum muaj tus kab mob kis thoob ntiaj teb COVID-19.

Koob Tshuaj Tiv Thai Kab Mob Moderna COVID-19 tsis raug tib hom kev tshab xyuas zoo xws li ib Yam koom uas pom zoo los sis tso kev los ntawm FDA.
