RE: (1) APPROVING THE TERMINATION OF TEMPORARY ASSIGNMENTS OF RAY BYRNE AS INTERIM ADMINISTRATOR AND ANN PITSNOGLE AS DESIGNATED STAFF AND (2) APPROVING THE TERMINATION OF CORRESPONDING TEMPORARY SUPPLEMENTAL PAY

WHEREAS, on October 25, 2018 the Board of Health passed Resolution 18-05 approving three temporary assignments through the transition and on-boarding from the current to new Administrative Officer with temporary supplemental compensation for additional assigned work; and

WHERAS, on May 30, 2019, the Board of Health passed Resolution #19-03 concluding the temporary assignment of Mike Riley and his corresponding 10% wage supplement and approving an additional 5% supplemental wage for Ray Byrne as sole interim Administrator; and

WHEREAS, the transition to a new Administrative Officer was completed on September 16, 2019 when Amelia Clark began employment with the Spokane Regional Health District; and

WHEREAS, Ray Byrne and Ann Pitsnogle completed on-boarding of the new Administrative Officer in the spring of 2020; and

NOW THEREFORE, BE IT HEREBY RESOLVED by the Spokane Regional Health District Board of Health as follows:

- 1. Ray Byrne's temporary assignment as Interim Administrator, and his temporary supplemental pay of 15% for such position, shall cease as of May 1, 2020, and he shall return to his position as Environmental Public Health Director at the rate of pay he was receiving prior to his appointment to Interim Administrator plus any normal increases in compensation that would have occurred-since November 1, 2018; and
- 2. Ann Pitsnogle's temporary assignment during the transition from previous to current Administrative Officer, and her temporary supplemental pay of 10% for such position, shall cease as of May 1, 2020, and she shall return to her previous duties as Executive Assistant at the rate of pay she was receiving prior to her assignment plus any normal increases in compensation that would have occurred since November 1, 2018.
